COMPLETION TYPE COST REIMBURSEMENT CONTRACT:

a. Performance of Contract Line Items 0001 and 0002 (and if exercised, 0003 and 0004, 0005 and 0006, 0007 and 0008, 0009 and 0010, 0011, 0012, 0013, and 0014) shall be accomplished on a completion basis as defined in FAR 16.306(d)(1). ### TECHNICAL REQUIREMENT NO. 80

#### DEVELOPMENT AND SUSTAINMENT OF THE US CAPABILITY TO MONITOR NUCLEAR WEAPONS TESTS

##### SECTION 1 SCOPE

The overall objective of this effort is to develop and implement improvements to the United States (US) capability to detect, locate, and identify nuclear weapons testing using radionuclide technology. This objective will be achieved through two separate approaches. First, [REDACTED] will continue to develop, evaluate, and integrate nuclear software and sensors so that the US remains at the forefront of nuclear monitoring technology. Second, [REDACTED] will assist the US in implementation and compliance with nuclear treaties. The former ensures the US has the best possible nuclear monitoring technology and the latter ensures the US has access to nuclear monitoring data that would otherwise be impossible or cost-prohibitive to obtain.

##### SECTION 2 APPLICABLE DOCUMENTS

##### SECTION 3 REQUIREMENTS

3.1 The objectives for the base and option years, stated above, are clearly identified in [REDACTED] Volume C: Statement of Work and shall be incorporated into the contract as the Statement(s) of Work.

3.2 The contractor shall identify, control, and document the hazards associated with this effort and the control methods necessary to eliminate or control the hazards in all test plans and operations. Significant issues shall be addressed in status meetings and included in an Urgent Special Technical Report.

3.3 The target for the monitoring station systems to the US-IMS RASA Stations is to complete the certification process for the stations in Oahu, Wake and Melbourne. The target for the US-IMS ARSA stations is to prepare for and initiate the certification process in 2004 for the station in Guam, Salchaket, and Sand Point. The requirements for the stations in Midway and Palmer will be determined at a later date.

ATTACHMENT I

Abstract Requirements

1. Contain 200 or less words.
2. Prepare an information abstract that succinctly informs the reader of the salient features of the subject studies. The organization of the report should be reflected in the abstract and should contain, as a minimum, the following elements:
  - a. The objectives and/or purpose of the investigation in enough detail to tell the reader whether the research concerns him.
  - b. The methods employed and the kinds of treatment given, mentioning materials, conditions, restrictions and limits, should be given without going into detail.
  - c. Results obtained and/or conclusions reached should be the major part of the abstract. New findings should be clearly stated, including important numerical values.
3. The terminology in the abstract should be the same as that in the report. Technical terminology of the abstract will become the subject terms for storage and retrieval of information about the report.

4. Unconventional or rarely used symbols and characters should not be used because they cannot be introduced into certain automatic data processing systems.
5. Superscripts, subscripts, power, exponents, Greek letters, and other symbols that cannot be represented by ASCII codes shall be verbalized.
6. No abbreviations and acronyms shall be used unless of universal knowledge.
7. No equation, footnotes, preliminaries.
8. No descriptive cataloging of data.
9. Security Classification – abstracts should be unclassified to the maximum extent possible while providing the necessary information. Classified abstracts should be closely marked.

INVOICING AND VOUCHERING:

a. When authorized by the Defense Contract Audit Agency (DCAA) in accordance with DFARS 242.803(b)(i)(C), the contractor may submit interim vouchers directly to paying offices. Such authorization does not extend to the first and final vouchers. Submit first vouchers to the cognizant DCAA office. Final vouchers will be submitted to the ACO with a copy to DCAA.

b. Upon written notification to the contractor, DCAA may rescind the direct submission authority.

c. Should the contractor decline to submit interim vouchers directly to paying offices or if the contractor receives written notification that DCAA has rescinded the direct submission authority, public vouchers, together with any necessary supporting documentation, shall be submitted to the cognizant Defense Contract Audit Agency (DCAA) Office, prior to payment by the Finance and Accounting Office specified in Block 12, Page 1, Section A, of Standard Form 26.

e. 
