A SOW

THAAD Missile Critical Design Review (CDR) Support, "Statement of Work"

1.0 The contractor shall provide expert support to the THAAD Missile Directorate. The primary means of providing expert support is through participation in the THAAD Missile related CDR activities. Prior to the Missile CDR, the contractor shall review THAAD Missile CDR data products, and provide concerns identified during review of the CDR data products in writing (e:mail acceptable). The purpose of providing concerns identified from review of CDR data products is to give the THAAD prime contractor and/or subcontractor time to prepare for discussion of these concerns at the Missile CDR. The THAAD Missile Directorate will provide access to Missile CDR data products. The contractor shall participate in the THAAD missile CDR. After the Missile CDR, the contractor shall provide a final written assessment (e:mail acceptable) of the THAAD Missile design, processes, and remaining concerns; as well as participate in resolution of contractor originated CDR action items.

2.0 The contractor shall interface, as required, with the THAAD prime contractor, [REDACTED]
