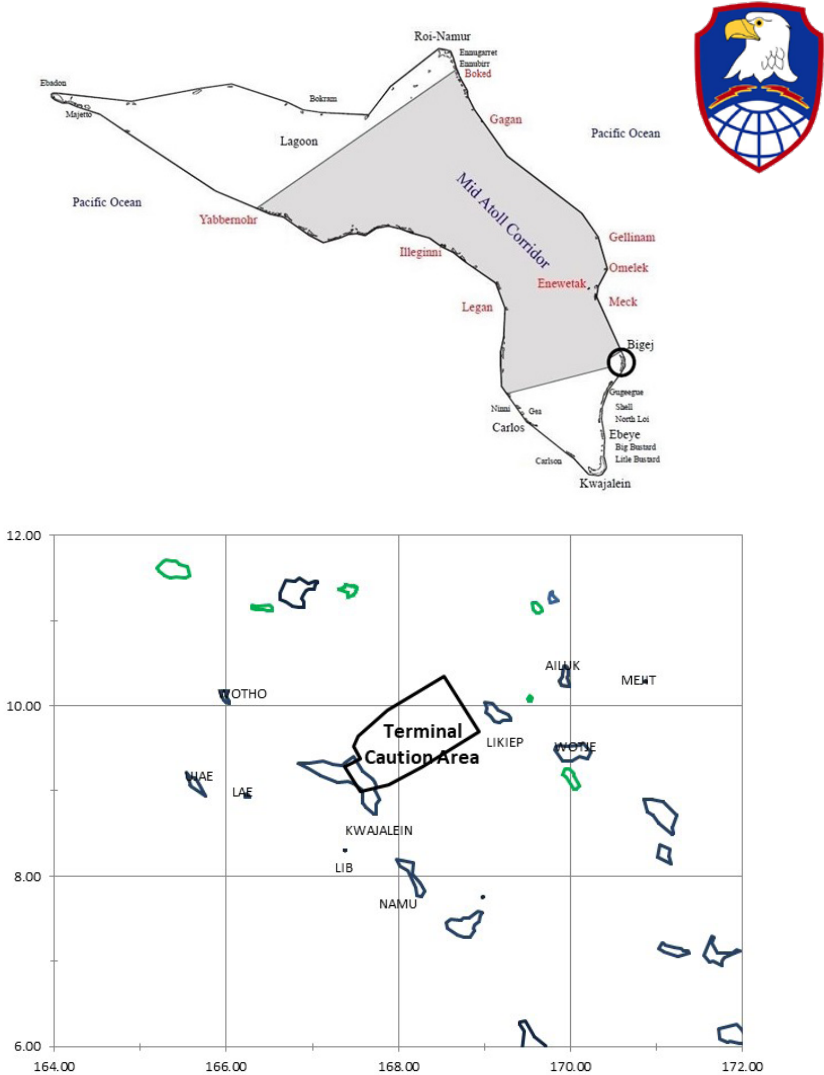

NMCB 4 BUILDS PICNIC SHELTERS AT EMON BEACH

Personnel from U.S. Naval Mobile Construction Battalion 4, Detail Marshall Islands, U.S. Army Garrison-Kwajalein Atoll command, Department of the Army civilian employees and island logistics gathered at Emon Beach April 16 for a ribbon-cutting ceremony to open three newly completed beachside picnic shelters.

USAG-KA Commander Col. Jeremy Bartel thanked the Seabees for their contribution to the island’s infrastructure for community recreation.

The shelters are located near the scuba shack and across from the A-frame

pavilion. Each open-air structure sports a picnic table and lights for evening use.

Initial construction was completed by NMCB 5 during a tour of duty in 2020.

Island residents were advised to stay clear of the marked construction zones throughout March until NMCB 4 completed work and any additional necessary carpentry, metalwork and electrical tasks to ensure the shelters were safe and ready for occupancy.

Following the ceremony, NMCB 4 Officer In Charge Lt. j.g. Mia McClain thanked on-island partners and the Seabees for their assistance and labor in completing the project.

“Troops, I want to say thank you for

making my job the easiest job here on island,” said McClain. “You are always on top of your game making sure we’re executing whatever we need to and communicating with whomever we need in to order to get everything accomplished. Thank you from the bottom of my heart. You guys are truly an amazing team, and I am blessed to work with you.”

LOGISTICS PERSONNEL KEEP ON TRACKING

Patience, says Logistics Supervisor John Barnhart, is essential when you’re tracking everyone’s cargo.

After logistics crews offload cargo at the pier and flight line, Barnhart and his team oversee the movement and tracking of class one materials—cargo utilized for base life support.

Regardless of the number of incoming containers, after being offloaded, each is collected by shipping and receiving personnel and unloaded, processed, officially received in and issued out or transferred to the appropriate island warehouse or facility.

“It’s like a giant load of laundry,” said Barnhart, of tracking the cargo, “but they’re not all your socks.”

Barnhart is the one who can corroborate whether any given item has arrived or is “on the next barge,” as the Kwaj saying goes. The most challenging aspect of work is to completely process documentation for one shipment before the next arrives, he said.

Then again, this process is familiar to him.

“I was the shop supply custodian [while performing] my regular job,” said Barnhart, of his service with the U.S. Air Force on aircrew life support teams. “It taught me everything I need to know. This is just

a process with different forms.”

Tracking more than 25,000 separate items can be tough and having employees you can count on helps. Ensuring uninterrupted operations with reduced staffing numbers proved challenging during 2020 when, due to RMI travel restrictions, employees were stranded abroad and unable to onboard.

Barnhart’s team bore up under their mission with reduced numbers. His RMI employees, many of whom are also trained in Hazmat and construction, stepped up to help meet the warehouse challenge each day.

“They’re very smart,” Barnhart said. “My guys know what they’re doing.”

Barnhart also recommends island departments support the materials processing system and work to ensure they are not overreaching to excess in their use of on-hand materials.

“Base life support is my mission,” Barnhart said. “So, me and my team just have to decide what is the highest priority.”

When every item on order is someone’s priority, patience is key. Sometimes, patience is meeting materials requests with unwavering perseverance.

“We’ve got a great system,” said Barnhart. “Let it work. You don’t need 10 boxes of red ink pens. Only take what you need out of supply, so it can keep what you need in the warehouse. It helps everybody.”

60 YEARS STRONG: YOKWE YUK WELCOME CLUB OBSERVES MILESTONE

It's been 60 years since the Yokwe Yuk Welcome Club—formerly the Yokwe Yuk Women's Club—began its mission to help fund education outreach in the Republic of the Marshall Islands and Federated States of Micronesia. As the YYWC recognizes its diamond jubilee, new members are encouraged to join and share creative fundraising ideas to continue the club's mission.

Under the current executive board, the YYWC organized fundraising opportunities and community enrichment activities on the garrison.

Harkening back to its original dinner and tea events, the YYWC hosted its first soup supper in January 2021. The fundraiser gave attendees the option to enjoy soup, bread and a dessert at the Religious Education Building or take it to-go. Other fundraisers included a quilt auction, March houseplant sale and April bake sale in time for Easter. Thanks to Mic Shop volunteers who arranged for the transport and sale of inventory items from Kwajalein, this month Roi residents were able to purchase Marshallese hand-icrafts at the Outrigger Bar.

"Through the generosity of our two communities, we raised more than \$5,800 with these [fundraising] events," wrote YYWC President Debbie Proudfoot in an email to the Kwajalein Hourglass. "This money, along with profits from the Mic Shop and Bargain Bazaar will be disbursed in the next month via grants and a Kwajalein senior scholarship."

Proceeds from fundraisers are used to purchase materials like updated curriculum and books, water dispensers, printers and construction materials for RMI and FSM school facilities. Past YYWC

fundraising events have included a gift basket auction, silent auctions, musical reviews, dinners, social events and cultural exchanges with Marshallese women's civic organizations.

Last summer, YYWC also launched "Talks on the Rock," a community lecture series. Featuring volunteer guest speakers from the community and RMI, Kwajalein residents have since enjoyed presentations delivered by Kwajalein MIA Project Director Dan Farnham; RMI Attorney General Richard Hickson; Massachusetts Institute of Technology Lincoln Laboratory Dr. Sarah Willis; and Dr. Nicholas Bird, chief medical officer of the Kwajalein Hospital.

Historically a women's club, the YYWC changed its name and officially welcomed men as members to promote inclusivity and diversity in 2020.

Club members will vote on new executive board members in May.

"We are looking for individuals committed to continuing this legacy, as well as ensuring that the Mic Shop and Bargain Bazaar remain a vital part of the community," said Proudfoot.

KWAJALEIN HOURGLASS HISTORY

RICHARDSON THEATER CLOSES

For years the Richardson Theater rose above a gray slab in the middle of the Central Pacific, surrounded by benches and athletics fields. It was a landmark, a novelty and an anachronism: a drive-in theater on an island with no private vehicles. The Rich was unique to Kwajalein.

Early photos taken after U.S. Navy Seabees built the theater in 1957 capture a familiar scene: the black and white glare of the sunlight on the shoulders of countless servicemen, all vying for a glimpse of the live act on stage—standing room only.

Over the years, USO artists such as Bob Hope graced the Rich stage, along with military bands and visiting performers from Armed Forces Entertainment.

The Rich remained one of the few venues veterans of Operation Flintlock, Kwaj kids, residents and visitors to the atoll all enjoyed in common. In time,

the theater would be renovated, refurbished and even rebuilt. It was in regular use until 2017 and best known to generations of Kwajalein residents as an outdoor movie theater.

On April 9, the theater began to fall.

Hours later, photos of the debris were shared on social media.

“The theater was torn down,” said FMWR Director Jeffrey Suis. “It just finally failed and collapsed because of the rain and wind. The Department of Public Works pushed down the remainder as it was unsafe.”

DPW personnel removed the debris and further secured the area. USAG-KA is considering alternative locations for family movie nights.

For now, the curtain has closed on a cherished historic landmark. The Rich lives on in Kwaj memory.

“For me, there is a special pleasure that goes with watching an outdoor movie with the family at the Rich Theater,” said Kwaj resident Bruce Premo. “When you think of all the previous residents who have enjoyed shows and gatherings there, it leaves an impression that is never forgotten.”

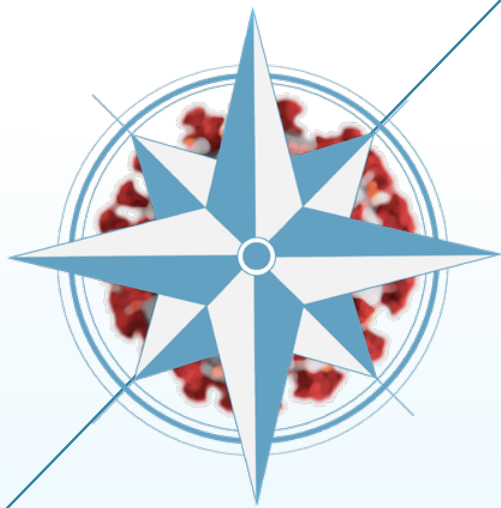

TRAVEL AND QUARANTINE

Tracking changes to RMI travel restrictions and travel regulations? Check back here each week for updates to island flight information, quarantine and Covid-19 testing information from U.S. Army Garrison-Kwajalein Atoll and Republic of the Marshall Islands.

Headed off island this summer? Be prepared.

The Kwajalein Hospital would like to remind you to that it will not be possible to fill prescriptions while you reside in quarantine. Please bring enough re-fills to last through your two weeks of quarantine in Honolulu and on U.S. Army Garrison-Kwajalein Atoll. A 90-day supplement is recommended. Also, while off island, it is recommended that island

residents seek any routine or specialized medical and dental treatment they may need—including mammograms, root canals and surgical extractions for wisdom teeth—if it is possible to schedule such appointments in advance with a primary healthcare provider. OUTBOUND COVID TEST POLICY

The Centers for Disease Control and Prevention released new travel guidance. The information that follows is current as of Jan. 30.

- A COVID-19 test is not required for any outbound travelers on the ATI.
- A COVID-19 test is not required if you are flying on United Airlines on official government orders.
- All other United Airlines passengers must have a negative COVID-19 test 1-3 days before travel.

If You Need A Test

You must contact the hospital at 5-2223 to schedule a time for your test. The Kwajalein Hospital is closed Sunday and Monday.

The cost of the COVID-19 test is \$125, due at the time of visit for everyone except for active duty service members and their family members. Cash, credit card and check are accepted forms of payment.

If you have previously tested positive for COVID-19 you must schedule an appointment with a provider 10 days prior to departure.

Passengers must bring a copy of their United flight itineraries at the time of their appointment for proof of flight.

For Outbound United Airlines Passengers Flying Without Government Orders

- Passengers will visit the hospital the day before their flight departs.
- Testing hours: 9 - 11 a.m.
- Results pick-up time is flexible on the day of departure.

These CDC requirements do not change or impact the state of Hawaii's testing requirement or quarantine procedure.

QUARANTINE PHASE TWO REDUCED TO TWO WEEKS

The RMI Phase 2 Quarantine Changes for Persons Traveling into the RMI from Countries with Covid-19 Community Transmission

As of March 25, 2021, the duration of the Second Phase of Quarantine on Kwajalein Atoll has been revised to 14 days. The total period of quarantine is now 28 days. This applies to all individuals entering the RMI from countries deemed high-risk for Covid-19 transmission (where community transmission is present).

The two-phase quarantine strategy remains in place and includes the following components:

1) Phase 1 – Secure and monitor hotel quarantine for 14 days in Hawaii. This includes a Covid-19 PCR test and an antibody test prior to entering quarantine, another Covid PCR test on day one and a final Covid PCR test within 48 hours of scheduled departure from Honolulu.

2) Phase 2 – Secure and monitored quarantine on Kwajalein Atoll for 14 days. This includes Covid-19 PCR tests and antigen tests on days 7 and 14.

This guidance is consistent with current WHO guidance on travel quarantine as well as other national health ministries and other public health agencies. This time period reflects the maximum incubation period for Covid-19 and includes individuals vaccinated against Covid-19 as well as unvaccinated individuals. Covid-19 variants of concern currently follow an incubation period of 14 days.

UNITED AIRLINES POLICIES FOR DEPARTURE

Customers at Kwajalein’s airport boarding United Airlines flights need to present the items described below:

Customers with a negative test result need to present written or electronic documentation which clearly indicates:

- **Customer name.** (The customer name and any other personal identifiers must match the customer ID).
- **Date the test was taken.** Test must be taken within three calendar days of flight.
- **Type of test.** The CDC rule requires a viral test, which means a molecular COVID-19 test (such as PCR or LAMP) or antigen test.
- **Results must state “negative,”** “SARS-CoV-2 RNA not detected” or “SARS-

CoV-2 antigen not detected.” A test marked “invalid” is not acceptable

Customers who have previously tested positive must present written or electronic documentation, dated within the last 90 days, of recovery from COVID-19 after previous infection.

This should be in the form of a positive viral test result and a letter on official letterhead that contains the name, address and phone number of a licensed healthcare provider or public health official stating that the passenger has been cleared for travel.

All United customers must also comply with the following requirements:

- **Presentation of a disclosure and attestation form.** The form can be found

on the CDC website and will also be available at the departure airport. Customers are encouraged to print and complete the form prior to arriving at the airport.

- **Check-In.** All international originating customers will be required to check-in with a Customer Service representative to verify digital or paper documentation. This mirrors the process we’ve set up within the U.S. for many international destinations.
- **Failure to Comply Will Result in Boarding Denied.** Customers who do not show proof of a test or refuse to test prior to travel will be denied boarding. Denied boarding compensation will not be paid. Customers in this situation shall be offered a refund or rebooked for a later date at no additional charge.

NOTE: These documentation requirements do not apply to customers flying from U.S. territories such as Guam to the mainland.

BENEFITS OF GETTING A COVID-19 VACCINE

COVID-19 vaccination will help keep you from getting COVID-19.

All COVID-19 vaccines currently available in the United States have been shown to be safe and effective at preventing COVID-19.

All COVID-19 vaccines that are in development are being carefully evaluated in clinical trials and will be authorized or approved only if they make it substantially less likely you will get COVID-19.

Based on what we know about vaccines for other diseases and early data from clinical trials, experts believe that getting a COVID-19 vaccine also helps keep you from getting seriously ill even if you do get COVID-19.

Getting vaccinated yourself may also protect people around you, particularly people at increased risk for severe illness from COVID-19.

Experts continue to conduct studies to learn more about how COVID-19 vaccination may reduce spread of the virus that causes COVID-19.

We are still learning how vaccines will affect the spread of COVID-19. Until we know more about how vaccines will affect the spread of COVID-19, people who are fully vaccinated against COVID-19 should keep taking precautions in public places like wearing a mask, staying 6 feet apart from others, avoiding crowds and poorly ventilated spaces, and washing your hands often.

People are not considered fully vaccinated until two weeks after their second dose of the Pfizer-BioNTech or Moderna COVID-19 vaccine, or two weeks after a single-dose Johnson & Johnson’s Janssen COVID-19 vaccine. You should keep using all the tools available to protect yourself and others until you are fully vaccinated.

COVID-19 vaccination is a safer way to help build protection.

COVID-19 can have serious, life-threatening complications, and there is no way to know how COVID-19 will affect you. And if you get sick, you could spread the disease to friends, family, and others around you.

Clinical trials for all vaccines must first show they are safe and effective before any vaccine can be authorized or approved for use, including COVID-19 vaccines. The known and potential benefits of a COVID-19 vaccine must outweigh the known and potential risks of the vaccine before it is used under what is known as an Emergency Use Authorization.

Getting COVID-19 may offer some protection, known as natural immunity. Current evidence suggests that reinfection with the virus that causes COVID-19 is uncommon in the months after initial infection but may increase with time. The risk of severe illness and death from COVID-19 far outweighs any benefits of natural immunity. COVID-19 vaccination will help protect you by creating an antibody (immune system) response without having to experience sickness.

Both natural immunity and immunity produced by a vaccine are important parts of COVID-19 disease that experts are trying to learn more about, and CDC will keep the public informed as new evidence becomes available.

COVID-19 vaccination will be an important tool to help stop the pandemic.

Wearing masks and staying 6 feet apart from others help reduce your chance of being exposed to the virus or spreading it to others, but these measures are not enough. Vaccines will work with your immune system so it will be ready to fight the virus if you are

A growing body of evidence suggests that fully vaccinated people are less likely to be infected without showing symptoms (called an asymptomatic infection) and potentially less likely to spread the virus that causes COVID-19 to others. However, further investigation is ongoing.

Stopping a pandemic requires using all the tools we have available. As experts learn more about how COVID-19 vaccination may help reduce spread of the virus that causes COVID-19, CDC will continue to update its recommendations to protect communities using the latest science.

COVID-19 vaccines are safe and effective.

We understand that some people may be concerned about getting vaccinated now that COVID-19 vaccines are available in the United States.

While more COVID-19 vaccines are being developed as quickly as possible, routine processes and procedures remain in place to ensure the safety of any vaccine that is authorized or approved for use. Safety is a top priority, and there are many reasons to get vaccinated.

None of the COVID-19 vaccines can make you sick with COVID-19.

None of the COVID-19 vaccines contain the live virus that causes COVID-19 so a COVID-19 vaccine cannot make you sick with COVID-19.

NOTICE OF AVAILABILITY FLIGHT TEST-3 (FT-3) FINAL ENVIRONMENTALASSESSMENT/ OVERSEAS ENVIRONMENTAL ASSESSMENT

The United States Army Rapid Capabilities and Critical Technologies Office and the U.S. Army Space and Missile Defense Command as Participating Agencies, have completed a Final Environmental Assessment / Overseas Environmental Assessment (EA/OEA) in accordance with the National Environmental Policy Act (42 United States Code 4321, as amended), the Council on Environmental Quality Regulations for Implementing the Procedural Provisions of NEPA (Title 40 Code of Federal Regulations [CFR] Parts 1500- 1508, July 1, 1986), the Department of the Army Procedures for Implementing NEPA (32 CFR Part 651), and Executive Order 12114, Environmental Effects Abroad of Major Federal Actions.

The Final EA/OEA analyzes the impacts of the continuing collection of data to demonstrate a reduction of risk for a longer-range payload system. Specifical-

ly, the FT-3 would continue to develop, integrate, and flight test a payload system to demonstrate the maturity of key technologies.

The U.S. Army RCCTO determined that a launch from the Pacific Spaceport Complex-Alaska to Kwajalein Atoll, Republic of the Marshall Islands (RMI) was preferred. They also considered the No Action Alternative, as required by the CEQ regulations. As fully analyzed in the Final EA/OEA, the U.S. Army RCCTO proposes one experimental flight test.

Based on the analysis, the U.S. Army RCCTO has determined in the Final EA/OEA that the activities associated with the Proposed Action are not expected to result in significant impacts to the environment. Based on these findings the U.S. Army RCCTO has prepared a Finding of No Significant Impact/Finding of No Significant Harm.

ARMY OUTLINES ACTIONS TAKEN ACROSS THE FORCE TO IMPLEMENT FORT HOOD INDEPENDENT REVIEW COMMITTEE RECOMMENDATIONS

EXTERNAL REPORT

WASHINGTON—The Army announced a slate of actions taken across the force to implement the recommendations of the Fort Hood Independent Review Committee, which examined the command climate and culture at Fort Hood and the surrounding military community to determine whether they reflect the Army’s commitment to safety, respect, inclusiveness, diversity, and freedom from sexual assault and sexual harassment.

Notably, the Army is in the process of re-structuring the U.S. Army Criminal Investigation Command and redesigning the Sexual Harassment/Assault Response and Prevention program to address shortcomings identified in the FHIRC report. Fort Hood’s CID detachment is fully manned with experienced agents and the office also has access to state-of-the-art software and digital-forensic-examination tools.

In addition to taking actions to significantly address each of the 70 recommendations set forth in the FHIRC report, the Army is working to achieve transformational cultural change by executing initiatives such as This is My Squad, the Army’s first-ever noncommissioned officer strategy, and the Command Assessment Program, which will ensure that only exemplary leaders are placed into critical positions of trust and responsibility.

“The People First Task Force is driving transformational change for the Army’s approach on the prevention of harmful behaviors that undermine cohesion and trust, particularly sexual assault and sexual harassment,” said People First Task Force tri-chairs Lt. Gen. Gary M. Brito, the deputy chief of staff of G-1; Ms. Diane M. Randon, the assistant deputy chief of staff of G-2; and G-2 Sgt. Maj. Julie A.M. Guerra. “We expect the redesigned SHARP program will look out for the best interest of our Soldiers and civilians by focusing on prevention, survivor support and holding leaders at all echelons accountable. However, it’s important to note that formations are already acting at the grassroots level by expanding SHARP 360 facilities and testing virtual reality technology. We applaud their initiative and will incorporate their best ideas and practices.”

Army implementation actions

In all, the Army has implemented five recommendations across the force, while Fort Hood, III Corps, and U.S. Army Forces Command have implemented an additional 16 recommendations. Responsive actions taken at Fort Hood and Army-wide include the following:

Army-wide

- Updated CID policies to require full investigations of off-post Soldier drug overdoses, including determination of the source of the drugs and the extent and nature of the Soldier’s involvement with illegal drugs. The updated policy also requires a full investigation of all suspected Soldier suicides occurring on or off the in-

stallation. (Recommendations No. 41 and 42)

- In December 2020, the Army issued guidance regarding missing Soldiers to clarify expectations and responsibilities of unit commanders and Army law-enforcement authorities when accounting for Soldiers who are absent from their place of duty. (Recommendations No. 43, 46 and 47)

FORSCOM/III Corps/Fort Hood

- The FORSCOM commanding general implemented a policy requiring commanders to select investigating officers from outside a subject’s brigade-sized element for formal sexual harassment complaints under Army Regulation 600-20, chapter 7. (Recommendation No. 13)
- The Department of Emergency Services now provides a brief at each III Corps and Fort Hood company commander and first sergeant course regarding the purpose of military protective orders and how they benefit Soldiers, commanders and units. (Recommendation No. 28)
- III Corps now disseminates a monthly “Teal Hash” message to the force that includes the results of court-martial convictions for sexual offenses. (Recommendations No. 29 and 30)
- III Corps commanders are required to update victims on Sexual Assault Review Board (SARB) results within 72-hours. (Recommendation No.31)
- Fort Hood’s CID detachment has access to state-of-the-art software and digital-forensic-examination tools. (Recommendation No. 36)
- Fort Hood has reinvigorated its Good Order and Discipline Boards and updated its list of off-limits establishments to protect the safety and health of military personnel and their families. (Recommendations No. 52 and 53)
- In October, III Corps and Fort Hood initiated Operation People First, a year-long effort designed to create trustworthy and engaged leaders and build cohesive teams; the initiative includes a leader certification program. (Recommendations No. 44 and 57)
- The Fort Hood installation commander now leads and directs the monthly SARB process. (Recommendation No. 64)
- The FORSCOM commanding general has authorized senior mission commanders to temporarily leverage crisis-response resources including public affairs, medical, legal, logistics and law-enforcement personnel as needed; Fort Hood has also expanded its outreach to key community groups. (Recommendations No. 66, 67, 68, 69, and 70)

People First Task Force

While the FHIRC report focused on the command climate and culture at Fort Hood, the findings impact the entire Army and more than 1.2 million Soldiers. The People First Task Force is developing multiple plans to address FHIRC rec-



ommendations for combating sexual harassment, sexual assault, violent crime, and other harmful behaviors that exist in our ranks across the Army.

- People First Task Force-led efforts to redesign the SHARP program are underway and members expect to present their recommendations to Army leadership soon for review and implementation.
- In March, the People First Solarium brought 100 junior enlisted and officers from across the total Army to the U.S. Military Academy to examine Army culture and the behaviors that negatively impact cohesion and trust.
- The People First Task Force is conducting pilot programs to measure unit cohesion and trust, as well as the effectiveness of programs meant to counter harmful behaviors such as sexual harassment, at select installations. The assessments include: Soldier interviews and small unit visits; surveys measuring morale and trust in leadership; and analyses of formations’ operations with regard to trust and cohesion, leader-development programs, training awards, legal actions and Soldier separation programs.

Background

The Fort Hood Independent Review Committee unveiled the results of a three-month examination of the command climate and culture at Fort Hood and the surrounding military community on Dec. 8, 2020. The independent review arose from the questions and concerns voiced by family members, Congress, and various Hispanic advocacy groups during the investigation into the disappearance and murder of Spc. Vanessa Guillén.

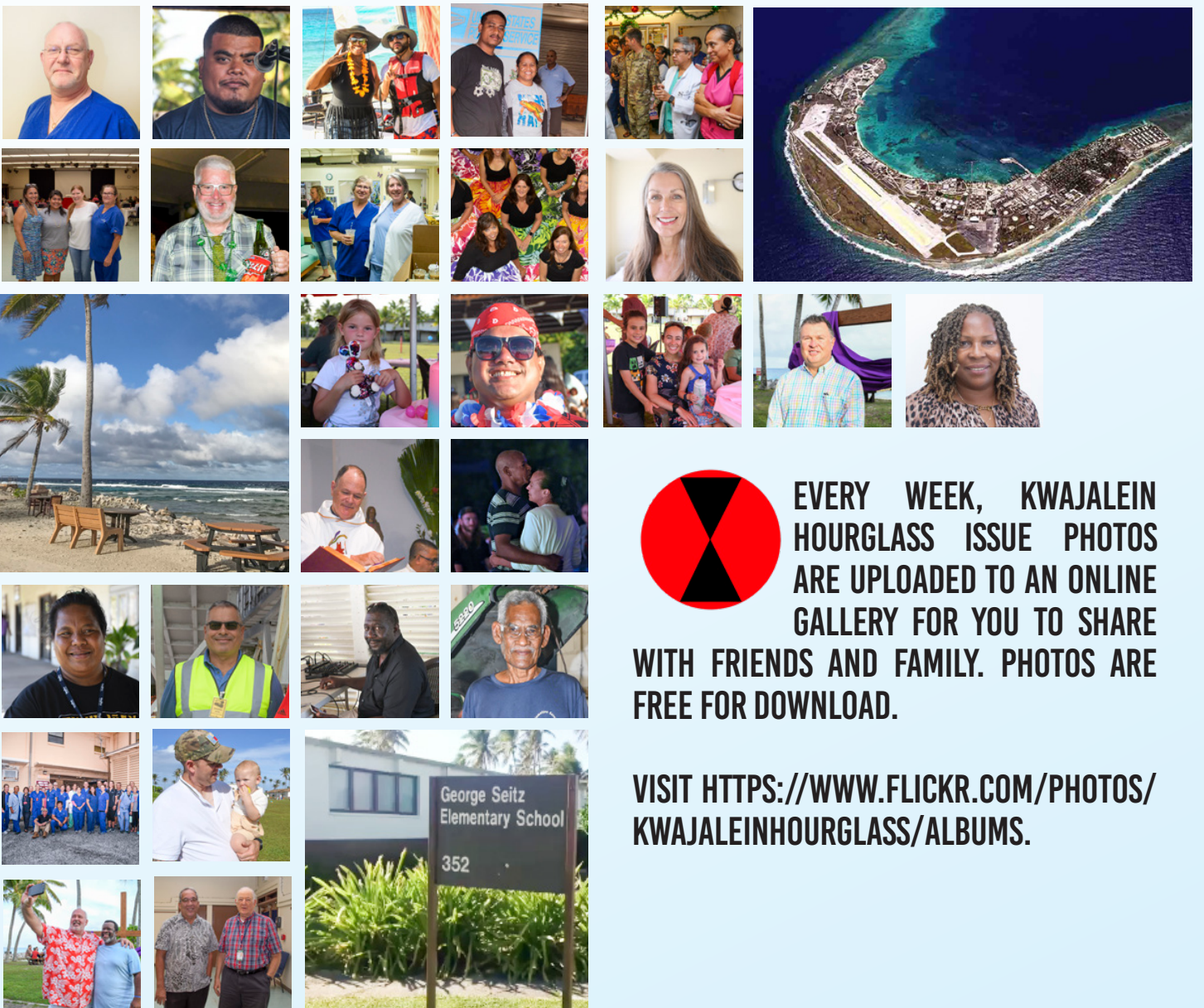
The FORSCOM commanding general appointed two related investigations under the provisions of Army Regulation 15-6. These on-going, complex, in-depth investigations are reviewing a number of aspects of the 3rd Cavalry Regiment and the 1st Cavalry Division at Fort Hood. Once complete, the investigating officers will make findings and recommendations for the appointing authority’s consideration.
