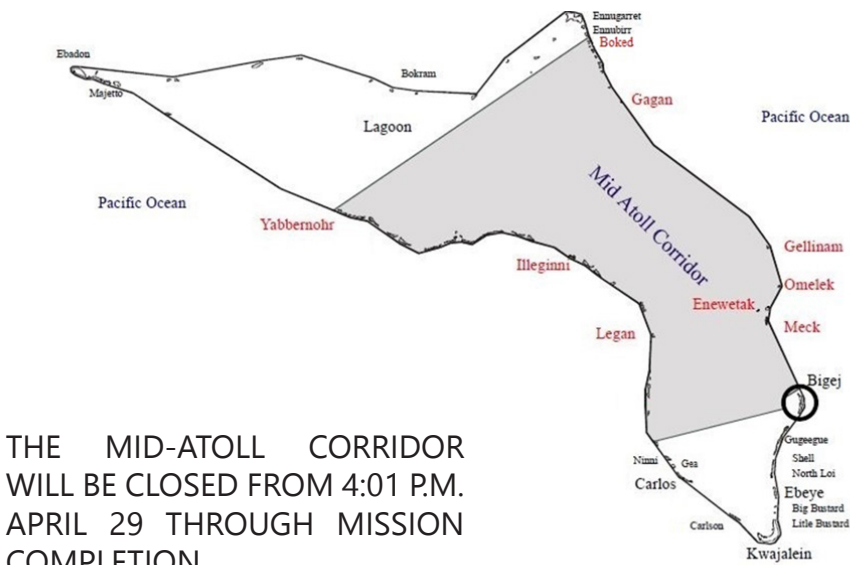

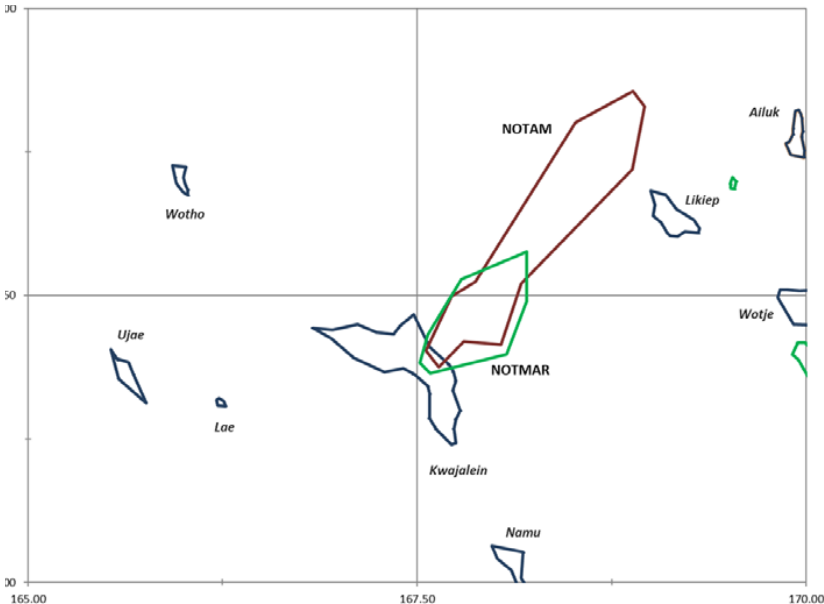

WATER PLANT REFURBISHMENT BOLSTERS USAG-KA UTILITIES

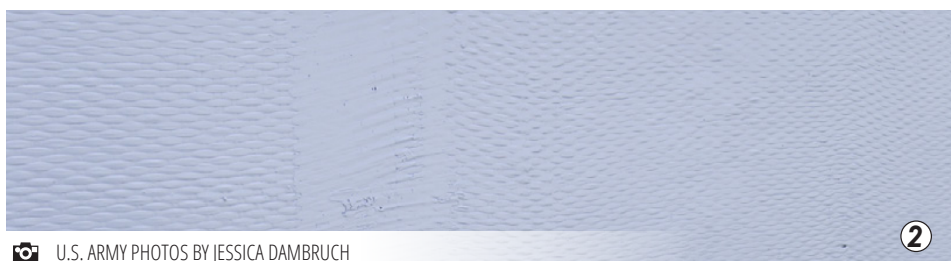
U.S. Army Garrison-Kwajalein Atoll Command Sgt. Maj. Ismael Ortega joined personnel at the Kwajalein Water Plant April 23 to commemorate the refurbishment of Treated Water Storage Tank #2. The one-million-gallon potable water tank stores water garrison residents require for everyday use in kitchens, homes and offices. Completion of the project represents a long-term cost savings for the garrison.

The treated water tank was built by the U.S. Navy in the 1950s. Over the years, it has suffered from corrosion and spalling. The refurbishment, which began in August 2021, is designed to extend the useful life of the facility into the future. It will also prevent leaks and provide system redundancy to facilitate refurbishment of other vintage water tanks.

The USAG-KA Department of Public Works coordinated a first ever “C” contract for this \$2.5 million dollar project via the 413th Contract Support Brigade in Hawaii to provide additional capacity beyond LOGCAP. The initiative was a follow-up to the initial pilot demonstration project, which provided the effectiveness of carbon fiber polymer reinforcement wraps to repair heavily degraded concrete. Ultimately, the repair was done at a fraction of the cost of a new tank build. The garrison requires 140,000 gallons of potable water per day for kitchens, showers, cooking, laundry and drinking water. It is important to have full use of the potable water storage system to meet those ongoing needs, as losing tank functionality would represent an incalculable failure.

To realize that goal, concrete restoration crews from Delta Structural Technology, a subcontractor to the prime contractor Cascade Solutions, identified compromised areas in the aged walls of the concrete tank. After chipping these out and removing old rebar, new concrete was poured in place. Next, the team wrapped the interior walls in epoxy impregnated fiberglass woven roving and added a joint membrane on the floor of the tank before wrapping the outside with fine carbon fiber, said project supervisor Jesus Murillo.

Restoration Specialist Blake Steele provided a small sample of the carbon fiber

material utilized in the project: a lightweight skein of black fiber wrapped in delicate bands of white thread.

Soaked in epoxy, once applied to the structure, the sheets of lightweight carbon fiber are designed to replace old rebar and create a strong structure to last for many more years in Kwajalein's harsh environment. It adheres to most objects, Steele said, which makes safety on the job a top priority.

“When we work with this stuff, we wear protective equipment,” Steele said. “After a while, it bonds and sticks to everything, if you aren't careful.”

Even so, Steele's teammates agree that the toughest part of the work was not the fiber-wrapping: it was waiting for the rain to stop.

Murillo said it feels good to complete the tank for the community. The team is now preparing to return to the United States to continue operations on upcoming projects. Kwajalein is the farthest away from home any of the crew have traveled, they said, and they welcome the chance to return to continue work on the Kwajalein Water Plant's storage tanks.

Now coated in a sleeve of slate gray epoxy, the modernized treated water storage tank stands in marked stark contrast to the bare concrete of its neighboring tanks in more ways than one. Its functionality improved, the new tank is a welcome sight for USAG-KA's Environmental Engineer, Gary Hutchinson.

“It looks so much better,” Hutchinson said.

CHILD DEVELOPMENT CENTER PLAYGROUND IS FOR LEARNING AND PLAY

Parents, employees and active-duty service members met at the Child Development Center on U.S. Army Garrison-Kwajalein Atoll April 26 for the grand opening of the facility's new playground.

Designed to support Army accredited programs for the island's youngest children, the playground project has been in development for the past six years. After being subject to delays exacerbated by the pandemic, it was recently completed by construction specialists from Lifecycle, Inc.

Lt. Col. Ben Jackson, director of USAG-KA logistics, thanked everyone present on behalf of Col. Tom Pugsley, USAG-KA commander, before cutting the celebratory ribbon draped over the playground's chain link fence.

"We all know Kwajalein is one team and one fight. We have to make sure families are taken care of as well," said Jackson. "I think this is a step in the right direction. ... We thank everyone for their time and their effort."

Following Jackson's remarks, CDC children ran inside the playground to try out the new equipment for the first time.

Playground design has changed over the years. On Kwajalein, CDC children can now play under sheltering sunshades on durable plastic climbing equipment, swing sets, slides, and learning stations with built-in percussion

equipment and water pumps.

Appreciating the differences in construction, Jackson shared his own memories of playgrounds he enjoyed while growing up in New Mexico.

"My playground had the 'dangerous' merry-go-round that you'd try to hang on to," he said. "The kids would try to fling you off. Also, those 15-foot swings that you'd jump off. We had basketball courts, and tetherball—and dirt."

In contrast, the CDC playground is compliant with the Americans with Disabilities Act. It includes special accessibility features at entry points. Those who walk near certain climbing equipment will notice that the ground may feel different, too. It is covered in a springy, artificial turf to cushion potential falls and activate kinesthetic learning.

Work crews also poured a circular sidewalk to connect different play features and even built a platform to accommodate the roots of a well-established tree.

For CYS Coordinator Dr. Stephanie McCutcheon, the playground represents years of ongoing teamwork between contract crews and garrison personnel to improve an important space for learning and play on Kwajalein.

"I just want to say thank you to everyone for making this a priority, and for getting it done, so we can get these kids out here," McCutcheon said. "Thank you to everyone."

ALOHA TRADITION THRIVES IN ANNUAL COMMUNITY HULA REVUE

On Kwajalein, one family's tradition to "share the aloha" continues to spread appreciation for Polynesian dance and culture.

More than 135 children and adults participated in this year's spring hula dance revue on April 24 at the Emon Beach Park. Produced by Kwajalein resident Masina McCollum, the dance classes continue the Kwajalein tradition begun by McCollum's mother, Palepa Smith, more than 33 years ago.

Over the years, the revue has included performances honoring Hawaiian culture and also cultural dance traditions from Tahiti, Samoa and New Zealand, among others.

Though some dancers on Kwaj begin classes hoping to try something new, they tend to learn more about the dance and Pacific in the process. Above all, they come away with an appreciation for the rich hula tradition.

"I want you to love hula," said McCollum in a 2019 Kwajalein Hourglass interview conducted during a practice. "There is freedom and beauty in it."

Families and friends also play a significant role in the weeks leading up to the dance recital performance, sometimes hosting impromptu practice or providing and assembling of the night's celebratory outdoor family pot-

luck dinner, including one special surprise guest.

Throughout the evening, each dance group made their distinctive entrance, forming long lines and groups that spanned the length of the audience. The Wahine, women's group; Kane, men's group; and teenage and child dance groups each performed multiple numbers.

One special performance recognized five Kwajalein High School senior students as they performed their last hula.

An aloha music combo assembled for the evening included ukulele group leader John Thygerson and Pure Aloha's Mike Sakaio.

They were joined by Mel Sanchez, a guest musician and longtime friend of the McCollum family.

A longtime island resident, Sanchez had performed with Palepa for the island's hula classes, or "halau." Though scheduled to PCS the next day, Sanchez accepted Masina's invitation to join the night's band to "share the aloha" with the night's audience.

During the evening, McCollum asked for a showing of hands. "Who is PCSing this year?"

Several hands raised from the audience.

"Our hula ohana loves you and sends you off with well wishes and hopes that you

continue to keep dancing forever," McCollum said.

Mike Sakaio took the microphone to share more of the story of the McCollum family history.

"Masina has carried on that [hula] tradition on Kwajalein," he said. "We are very grateful that she is able to do this, and to share her talents and the culture with everyone on the island. Thank you to Masina, to her family—Mark, and the children. This wouldn't have happened without your contributions."

Following the performance, family and invited guests enjoyed an outdoor potluck to spend some quality time with "ohana," family.

GARRISON RECEIVES SMALL VISITORS WITH BIG QUESTIONS

It's not every day that the garrison receives a big visit from small visitors.

Young students enrolled in the U.S. Army Garrison-Kwajalein Atoll Child Development Center were guests of honor during a field trip to command headquarters April 27 in celebration of the Month of the Military Child. Students and staff met with command team members and learned a little more about a day on the job at the garrison.

The Soldiers and Department of the Army civilians on duty answered questions to help make their daily work more relatable to their young visitors.

USAG-KA Director of Plans, Training, Mobilization and Security—or DPTMS—Maj. William Strouse addressed the students first at his office. He likened his role on the garrison to being in school.

"You have the adults that are there at the CDC, and they tell you what to do, where to go, and how to act," Strouse said. "We have the same thing, over in Hawaii, at our higher headquarters. They tell us all the things they want us to do for them, and then I get to tell the people here to do all those things."

helicopter pilot Lt. Col. Ben Jackson was most recognizable to the young visitors as the father of one of their classmates—a veritable "helicopter parent." Jackson said he tried to visit every island.

"The garrison has a responsibility to go to all the islands and make sure things are working," Jackson said. "Who likes going to Roi for pizza and burgers? We help make sure those things are available."

At his office, Command Sgt. Maj. Ismael Ortega let students peruse some of his service awards and deployment mementos he has collected over the years.

On the wall behind his desk hangs a framed ink drawing of a lion.

"This was given to me by a lieutenant at my last unit," Ortega said. "The codename for our battalion was the 'Red Lions.' I was Red Lion Seven. My lieutenant hand-drew

this and gave this to me. That was a couple of years ago."

"That's a MOC," one student said, correctly identifying the wooden model of a mobile operation center vehicle on the desk.

"This can carry six rockets and help protect us from enemies," Ortega said. "This is just a wooden one, but there are real ones."

The students next convened in the conference room to ask the team ques-



tions while enjoying treats. Ortega shared his favorite color (blue) and his favorite food (Roi Outrigger meat lovers' pizza).

Did he get to drive a Hum-vee on the job?

"I think we have one Hum-vee in the fleet on the island," Ortega said. "I don't get to drive that one. I did get to drive some at Fort Lewis, Washington. Col. Jackson has the best job. He gets to fly helicopters!"

Then, a tough question: What's a garrison?

"We're going to let our lawyer answer that one," Ortega said.

"Think of it like the guard—the unit that's here that employs and oversees this post," said USAG-KA Attorney David Creed. "A post, or a fort, is the actual physical location. The garrison is the actual people that work in that location—that serve."

"So, Col. Pugsley sits in that chair, and the rest of us sit in these chairs, and we give advice, and say, 'Sir, here's what we should do, or what the garrison should do,' said Creed. "He gets to decide, 'Yes, we do this,' or 'No, we do this.'"

The next item on the agenda called for the students to convene at the Grace Sherwood Library, so the garrison team finished their meeting and bade their visitors farewell until their next visit.

As the students travelled down the hall, Ortega called out cadence. Together, they fell into step as they returned to their bus.

"On behalf of Col. Pugsley, thank you for coming," Ortega said.

43 RUSTMAN HISTORY & LEGENDS

The 43rd annual RustMan Triathlon is one of Kwajalein's oldest and most beloved community events. Each year, volunteers sling water to bikers and runners, check times, cheer, set up, tear down, clean and staff the course to clear the way for RustMan history to be made by teams and solo athletes.

After a safety briefing at Emon Beach with event organizers Bob and Jane Sholar, Kwaj athletes take on the 1-km swim, 42-km bike and 10-km run segments, working to best personal times and break historic records. They stretch the island's small square footage into the distance needed to race to the finish line, and overcome snapped bike chains, injuries, foul weather and fatigue to cross the finish line and claim victory.

It is during the post-race awards ceremony, as Sholar recounts race results as compared to previous years' data, that the event reveals itself as more than an athletic challenge. The race data captures island history and with it, something of the lives of those who competed.

RustMan history is as compelling as cheering on competitors. For example, this year marked T.C. Cardillo's 16th RustMan, eighth overall win—the most wins for anyone, ever, in all 43 years of the event—and the 12th year overall for his partner, Christi.

“I remember telling T.C. one year, ‘If you trained a little, you could win the RustMan,’” said Sholar in his remarks. “I had no way of knowing what the next few years would be like.”

Sholar has said in the past that he once bested T.C.’s score one year on account of the latter’s bike trouble. Kwajalein High School senior Kim O’Rourke faced a similar issue this year but was able to regain her bike and meet her goal to complete the entire triathlon solo. Kwajalein resident Matthew Griffin was able to complete the swim and bike segments before an injury sustained on the course left him unable to continue the event.

This year’s race also included two active-duty service members—Capt. Hardy Temoney II, USAG-KA Directorate of Logistics, and Lt. Gregory Kemper, U.S. Naval Mobile Construction Battalion Three, Detail Marshall Islands Officer in Charge.

“I knew I could do it,” said Lt. Greg Kemper, of his participation this year. “I just wasn’t sure how hot it was going to be. I started hydrating on Saturday night to prepare.”

Dr. Lauren Wallach, David Bates and Leightyn Cossey each earned a personal best on the course, and one exciting development helped a new athlete earn his place in RustMan legend. This year an historic record was broken, as nine-year-old Rowen Primeaux completed his first solo in his first-ever triathlon at 3:57:31, surpassing a record set in 1980 by Jeff Stegall, an athlete of the same age.

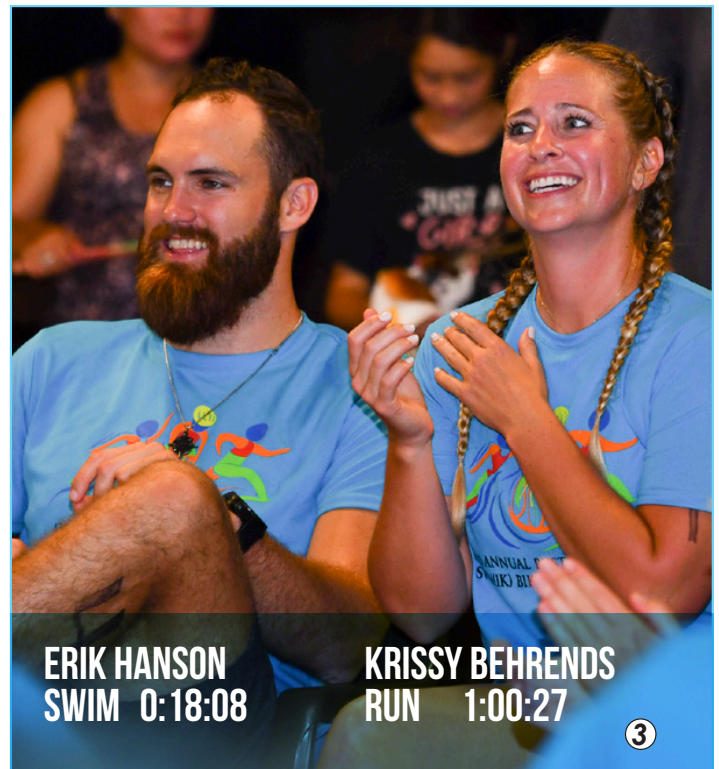

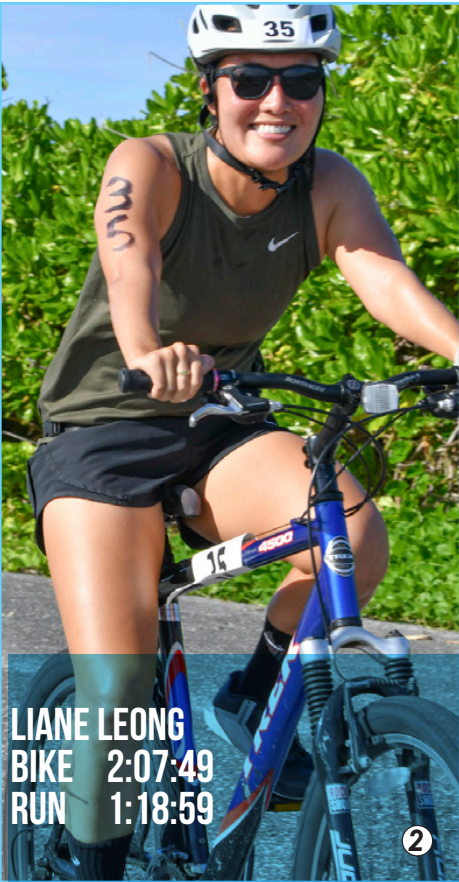

MINUTEMAN III MODIFICATION/FUZE MODERNIZATION FLIGHT TESTS AND GROUND BASED STRATEGIC DETERRENT (GBSD) TEST PROGRAM DRAFT DOCUMENT OF ENVIRONMENTAL PROTECTION (DEP)

PUBLIC NOTICE

The United States Department of the Air Force, Global Strike Command and Space Launch Delta 30 of the U.S. Space Force has prepared a Draft Document of Environmental Protection for the Ground Based Strategic Deterrent Test Program Environmental Assessment/Overseas Environmental Assessment, in accordance with the U.S. Army Kwajalein Atoll (USAKA) Environmental Standards and Procedures (UES), Section (§) 2-17.3.1(j).

The 2021 EA/OEA analyzed the implementation of the GBSD Test Program, which represents the modernization of the U.S. land-based nuclear arsenal, eventually replacing the aging Minuteman III intercontinental ballistic missile system.

Before DAF can make future decisions to transition the Minuteman III weapon system from active status to the GBSD weapon system, developmental and operational program testing of the new system must occur.

Because the proposed GBSD Test Program would overlap several years of Min-

uteman III flight testing, the Proposed Action analyzed in the 2021 EA/OEA took into consideration actions and resulting impacts that would occur from conducting both GBSD and Minuteman III test programs in parallel.

All missile demonstration programs proposed to occur at USAKA and within the Republic of the Marshall Islands territorial waters must comply with the UES. The Draft DEP outlines the activities proposed to occur at USAKA and within the RMI.

Target locations would include the Kwajalein Missile Impact Scoring System, offshore of Illeginni Islet, and land impact on Illeginni Islet.

For GBSD flight tests conducted at U.S. Army Garrison-Kwajalein Atoll, up to approximately nine test reentry vehicle impacts per year would be conducted starting in fiscal year 2024 and continuing until FY 2029. While most test RVs would be targeted at the KMISS ocean area or deep waters in the vicinity of Illeginni Islet, up to three total land RV impacts may be possible at Illeginni Islet through FY 2029.

GENERAL ORDER ONE: KNOW THE RULES

The music is pounding at the club. You've had a few drinks. You eye someone on the dance floor you want to get to know better. You walk over and make your move. What could go wrong? Plenty. Keep reading.

If you are a member of the military, to include National Guard (when in Title One status), attached, assigned or under the operational control of the Commander, United States Army Pacific Command, then General Order One applies to you.

What is General Order One?

Signed by Gen. Charles A. Flynn, U.S. Army Pacific commanding general, General Order One establishes command policy concerning the conduct of USARPAC personnel within the Indo-Pacific area of responsibility. This includes but is not limited to policy and regulations regarding leave, alcoholic beverages and controlled substances. Certain provisions of this order are punitive, violations of which are punishable under Article 92, Uniform Code of Military Justice when outside the U.S. and its territories.

Further, all USARPAC personnel must avoid any action, whether specifically prohibited by this general order, which might result in or may reasonably be expected to create the appearance of a violation of local law or customs. Commanders may implement their own more restrictive policies and regulations that are consistent with their mission, including this policy and the policies articulated in reference B.

I'm a Department of the Army civilian or a contractor. Does this apply to me?

This order does not apply to those personnel permanently assigned in the area of responsibility or who are not on temporary deployment orders. This order does not apply to Department of Defense Civilians servicing, with, employed by, or accompanying forces attached, assigned, or under operational control to USARPAC. This order also does not apply to DoD contractors; however, both DoD Civilians and contractors are reminded that the commander, USARPAC, is responsible for the good order and discipline of USARPAC forces in the AOR. As such, conduct that is detrimental to good order and discipline and/or unprofessional, may result in appropriate disciplinary or

administrative action. Also, DoD contractors are bound by the terms of their contract and may be removed from their duties for violation of terms within this order as provided for in their contract.

Leaders at all levels will ensure that all personnel are briefed on the content and requirements of this order prior to TDY/deployment, and are expected to enforce this order within their respective legal authority. Leaders will also ensure that they are aware of, and brief personnel on, other general orders and reporting requirements that apply based upon the specific TDY/deployment mission.

The U.S. Army plays a vital role in influencing how the rest of the world views our nation.

An individual Soldier's actions can have far-reaching effect. Misconduct undermines trust and brings discredit to the U.S. and the Army profession. Soldiers serve honorably according to the Army ethic while obeying the laws of the nation and all legal orders.

USARPAC personnel must take pride in honorably serving the nation with integrity, demonstrating character in all aspects of our lives. Commanders must ensure that proper procedures are in place to ensure compliance with this order and to ensure our personnel meet the nation's

high expectations of personal and professional conduct.

USARPAC personnel are guests in whichever country they are deployed on temporary duty. Everyone is an informal ambassador representing the nation. Army professionals recognize the intrinsic dignity and worth of all people. USARPAC personnel will treat all people with respect, and demonstrate proper consideration for all. They will be considerate of customs of the host nation and will not knowingly engage in any offensive behavior, wear offensive clothing, or make offensive statements. USARPAC personnel are responsible to become familiar with and respect host nation laws insofar as those laws do not interfere with the execution of official duties.

Leaders must ensure personnel are briefed on host nation customs and laws. Leaders must establish and maintain within their commands and for themselves the highest standards of personal conduct. Professional conduct is expected by all personnel at all times.

Punitive Provisions

The following provisions are punitive and are enforceable as violations of Article 92, the Uniform Code of Military Justice for military personnel:

DoD civilian employees and contractors are subject to applicable criminal law and may be subject to prosecution by the U.S. government under the Military Extraterritorial Jurisdiction Act.

Alcohol Consumption. USARPAC personnel who consume alcohol will do so in moderation, balancing the desire to participate and strengthen ties with allies with the overarching requirements to maintain professionalism and antiterrorism/force protection awareness at all times.

We represent the armed forces and the United States. Drunkenness that is prejudicial to good order and discipline in the armed forces or of a nature to bring discredit upon the armed forces is a violation of the UCMJ.

Prohibited Activities. The introduction, purchase, possession, use, sale, transfer, manufacture or consumption of any controlled substance, controlled substance analogue (any substance designed to mimic the effects of a controlled substance on the human body without an approved medical use in the U.S.), hemp, hemp or cannabinoid oil products, or any drug paraphernalia – to include over-the-counter medications – even though such purchases may be legal under host nation law. Personnel shall ensure prescription medications are accompanied by original prescription labels of the prescribing medical facility or authority.

Prescription medication includes any substance for which U.S. state or federal law requires a valid prescription for dispensing. Any medication, including over-the-counter medications, possessed in the host nation, must be obtained from, or under the direction of, DoD-approved

medical personnel.

Sexual conduct or solicitation that violates the UCMJ, even if such conduct is legal under host nation law. Allegations of such misconduct will be investigated promptly.

Possessing or handling unexploded ordnance of any kind or description, without legal authority.

“Without legal authority” means any act or activity undertaken by USARPAC personnel that is not done at the direction of a commanding officer or as a result of military necessity during the performance of official duties.

Purchasing, removing, possessing, selling or defacing archaeological artifacts or national treasures.

Selling, reselling, loaning or otherwise transferring imported tax-exempt items (e.g., items purchased from AAFES) unless specifically authorized under applicable DoD regulation.

Duty to Report. USARPAC personnel observing other USARPAC personnel violating the prohibitions of this order, or otherwise acting in a manner which is likely to result in personal injury or damage to property, have a duty to report the matter to the chain of command.

Should an incident occur between any USARPAC personnel and a citizen of a host nation, immediately report the incident to the senior USARPAC person present.

Enjoy your time on Kwajalein whether you are here for a few weeks, a few months or a few years. Drink responsibly and be respectful of others. Your career, and the people of Kwajalein, will thank you.

U.S. ENTRY REQUIREMENT A REMINDER TO ALL DEPARTING ON UNITED AIRLINES

It is a requirement of the Centers for Disease Control and Prevention that all passengers have a negative COVID test one day prior to departure.

How does this impact you? If you are traveling to the U.S., you must call the hospital no later than a week prior to your departure to schedule your COVID test. Payment will be expected at the time of service.

***EXCEPTON:** Government, Active Duty or DoD Civilians/dependents traveling on official orders do not require a COVID test to fly on United Airlines.

ATTENTION ALL USAG-KA RESIDENTS

Remember, it is illegal to remove cultural resources from the atoll. This includes any protected species, unexploded ordnance, WWII-era artifacts and ancient Marshallese artifacts.

These resources are protected under U.S. federal and RMI law. Please do not remove these precious pieces of atoll history from Kwajalein. For any questions about cultural resources, please contact the Kwajalein Archaeology Office at 5-9502.

U.S. Army Garrison Kwajalein will undergo an installation-wide facility inspection program between May 4 and June 11.

WHERE: USAG-KA Army Family Housing and Bachelor Quarters

WHEN: May 4 through June 11, Tuesday through Saturday, from 8 a.m. - 5 p.m. Housing residents are not required to be home during the inspection, which could take 60 to 90 minutes.

WHY: Inspections of Army Family Housing and BQ facilities are required by HQ IMCOM to document standardization of facility conditions. Inspections will allow consistent reporting to the Army's real property database and provide analytical data for resourcing of funding.

Housing-escorted contractor teams of two to five assessors from Wood, PLC, will be required to enter your housing unit to complete a visual inspection of building components. The contractors must access all interior and exterior spaces to take measurements and document findings. The contractors are required to take photos of building components but will not take photos of residents or per-

sonal identifiable information such as names, photos and certificates.

A full schedule is being developed, and can be found on the next page. Please note there could be short-notice changes to the schedule. This is a mandatory inspection that helps standardize documentation of facility conditions.

Before Inspection Day

To ensure safety for your pets and our inspection team, before inspections begin, it is required that all pet owners please notify Jim Streetman via email if you have a dog and/or cat residing in your house. Some team members may be allergic to cat hair and pet dander. All pets must be secured before entrance into the home and remain secured until our team departs your home.

OIL/WATER SEPARATORS

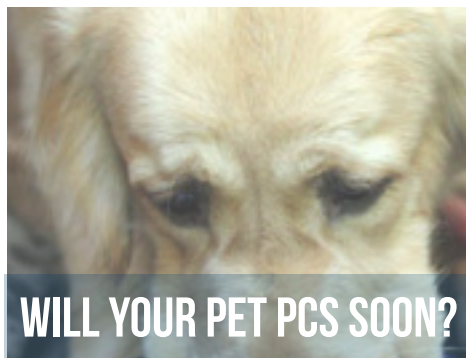
What is an Oil/Water Separator?

An OWS is a device used to separate oils and greases from a variety of industrial wastewater discharges. The effluent (mostly water) from the OWS is typically discharged to the wastewater treatment plant (WWTP). It is important to properly utilize and maintain OWSs to prevent sources of environmental pollution and upsets at the WWTP. Call Vec-trus Environmental at 5-1134.

Please notify island veterinary services as soon as possible if you plan to PCS with your pet. COVID has created increased delays in some necessary testing needed for most destinations outside of CONUS.

If a Fluorescent Antibody Virus Neutralization test is needed for your PCS, it could take eight weeks to receive results. You should allow three to six months to leave Kwajalein with your pet(s), however if you need to leave on shorter notice, Vet Services may be able to help.
