MEMORANDUM FOR Subordinate Commands, Tenant Units, and All Individuals Located on U.S. Army Garrison Kwajalein Atoll

SUBJECT: U.S. Army Garrison - Kwajalein Atoll (USAG-KA), COVID Work Safe, Live Safe Order #2

PURPOSE. This order seeks to educate the residents and visitors located on USAG-KA and identifies conduct that is prejudicial to good order and discipline, health, and safety of all personnel residing or working on the USAG-KA.

AUTHORITY. 10 U.S.C. Chapter 47 (Uniform Code of Military Justice); Title 18 United States Code 1382; Army Regulation 600-20 Army Command Policy; USAG-KA Policy 8-1, Command Sponsorship, USAG-KA Regulations 190-10, Entry & Exit Control; 190-50, Administrative Bar Actions, and W52P1J-19-F-0398 Contract Technical Exhibit I.

APPLICABILITY. This Order applies to all individuals located on USAG-KA including those subject to military orders, DoD personnel, dependents, contractors, and individuals stationed, and/or attached to units on USAG-KA, whether on or off the installation. This includes units, teams, and organizations rotating through and/or visiting USAG-KA for any reason including but not limited to missions, inspections, and training. For purposes of this memorandum, USAG-KA includes the eleven defense sites of the Kwajalein Atoll, all work and training areas, housing of all kinds, and all infrastructure and locations not specified.

- 1. USAG-KA is currently at HPCON-B+, expectations and actions are defined as follows:
- Occupancy is limited to 75% of normal occupancy at any given time in the workplace, specifically areas where adequate social distancing cannot be achieved. Managers are encouraged to look for alternative workspace or work schedules to meet this requirement. Exceptions for mission critical personnel must be approved by Organizational Program Manager.
- Maximize telework where possible, especially for individuals who self-identify as immunocompromised or being at high risk as confirmed by medical staff.
- Mandatory Mask wear in indoor common areas and communal workspaces including schools/CDC/CYS as well as all government-owned or contract-operated vehicles, planes and marine assets.
- Limit occupancy and maintain physical distancing in all common areas to 50% of maximum occupancy where > 20 personnel are likely to congregate and interact. Reduce seating in common areas to maintain physical distancing (Zamperini Cafeteria, Food Court, Shopette, PX, bakery, Ocean View, and the Golf Club).
- Space-A access and non-essential travel to ROI / Ebeye has been Suspended.
- Guest sponsorship program is suspended, to include all non-C Badge holders and domestic workers unless an exception (childcare providers) is granted by USAG-KA Host nations Office.
- All community activities, MWR, social events, and public or private gatherings > 20 are prohibited and/ or canceled. Exemptions will be

- approved through the USAG-KA MWR office for organizations with approved plans. Currently religious services, swim team, and MWR soccer are exempt from this restriction.
- Reduce non-essential services (fitness centers, leisure and recreational facilities, beauty/barber shops, clubs, and non-essential retail) to < 50% maximum occupancy. Social distancing and mask requirements must be met.
- STATEMENT OF MILITARY PUR-POSE AND NECESSITY. The arrival of COVID-19 to the Marshall Islands requires balance between mitigation measures and maintaining readiness. These measures preserve force readiness, limit the spread of COVID, and the health and welfare of service members, DA civilian employees, contractors, families, and the Marshall Islands.
- COMPLIANCE WITH LOCAL HEALTH ORDERS. All service members, family members, DA Civilians, and Contractors, both on and off post, will comply with all applicable provisions of Command authority and respect the laws of the Republic of the Marshall Islands regarding public health orders including local directives regarding the use of authorized facial coverings when outside of one's home. In the event this order imposes a more restrictive requirement than the Republic of the Marshall Islands, the terms of this order shall take precedence over any order issued by the Marshall Islands.
- 4. VISITATION RESTRICTIONS. Currently, the guest sponsorship program is suspended. An exception may be granted for childcare workers. Any gathering of more than 20 personnel is prohibited without an approved exemption.

- See Paragraph 1 for guidance. This includes BQs and personal residences as well as access to other defense sites, to include Roi-Namur. "Residence" means the property boundaries of the residential property, including the front and back yards. "Household" is defined as back yards. those individuals living in the residence and their immediate family members. "Immediate family members" is defined as those parents, grandparents, siblings, and adult children of household members not living in the residence. Individuals (excluding immediate family members) that do not live within the residence are considered members of a separate household.
- 5. DINING-IN. At this time, all personnel are allowed to dine-in at the Zamperini Dining Facility and Café Roi while observing proper distancing and guidance. Use of delivery and pickup services and appropriately distanced dining-in at other USAG-KA dining venues including but not limited to AAFES Food Court, the Bakery, Outrigger (Roi-Namur), and American Eatery is authorized.
- RETAIL SHOPPING GUIDANCE. In-person shopping at open retail venues is currently authorized. Personnel are strongly encouraged to: (1) maximize the use of COVID mitigation measures; (2) maximize the use of pickup/deliver services; and (3) minimize the number of household members entering such loca-
- 7. ESSENTIAL ACTIVITIES & TRAVEL. For purposes of this order "essential activities or services" includes, but is not limited to: official government duties, care of others (including adult and child caregivers), and services necessary for the maintenance of a residence or the property contained therein. At this time,

Space A and non-essential/leisure travel to Roi and Ebeye/3rd Island is suspended. Travel to the Outer Islands and Majuro is restricted by the President of the Marshall Islands.

8. PRIVATE & PUBLIC GATHERINGS, MILITARY CEREMONIES. HPCON B+ includes guidance for personnel in regard to hosting, attending, or participating in any gatherings that violate public health orders. Outdoor social gatherings of greater than 20 people are prohibited, as outlined in Paragraph 1. Every effort must be made to properly enforce social distancing. This prohibition does not apply to outdoor events that have approved plans and exceptions (soccer, swim team, and religious services) as outlined below in paragraph 13, as well as outdoor physical training conducted IAW paragraph 9, below. Social gatherings in a residence are authorized only IAW paragraph 4, and only when adequate social distancing can be enforced. Social gatherings, private or public, outside of a residence are only authorized within buildings, facilities, or locations subject to the rules established by the Garrison Commander IAW paragraph 13, below. Military ceremonies including change of command, change of responsibility, promotions, awards, memorials, hail and farewells, will comply with guidance issued by US-AG-KA Protocol Office. Any questions regarding such events should be directed to Rick Krewson at frederick.m.krewson. civ@army.mil

9. UNIT FORMATIONS & PHYSICAL TRAINING. Physical training for all personnel may be conducted in groups in accordance with the current HPCON guidance. Accountability formations will be conducted as required. Close-order formations are currently not authorized. All in-person formations will be conducted with adequate social distancing measures (6 feet minimum), and Personal Protective Equipment (PPE) is required.

10. PLACE OF DUTY & TELEWORK. All personnel subject to this order will report to their regular place of duty during normal work hours unless authorized telework. Employees should be prepared to telework. Current guidelines allow for less than 75 percent occupancy of common workspaces. Supervisors authorized to approve telework are encouraged to balance telework options with in-person work for employees and subordinates, based on many factors, to include office layout (common area or private offices), individual health considerations, mission requirements, and unit morale.

II. DUTY UNIFORM. Based on current HPCON guidance, personnel are required to wear an authorized face covering while in any duty uniform. While in a federal facility, or performing official duties, personnel including all military, civilian, and contractors, are required to wear a professional face covering that complies with applicable CDC guidance. Authorized supervisors may grant exceptions pursuant to mission requirements. This requirement will not apply while driving a cart or bike alone, eating/drinking, or actively conducting physical training. See paragraph 1 for guidance.

MASKS IN FEDERALLY FUNDED TRANSPORTATION. All individuals must wear a mask on DoD aircraft, boats and other maritime conveyances, and buses traveling into, within, or out of the United States, and indoor DoD transportation hubs, regardless of vaccination status and CDC COVID-19 Community Levels. Masks are optional on outdoor areas of these conveyances (if such outdoor areas exist on the conveyance) or while outdoors at transportation hubs, if adequate social distancing can be maintained. Masking requirements apply whether the DoD aircraft, boats and other maritime conveyances and buses are located inside or outside the United States, but exclude these conveyances and other tactical vehicles and craft in their operational environment. Masks are not required if the driver is the sole occupant of the vehicle.

13. ACTIVITIES. All activities (social, recreational, religious, etc.), businesses or facilities available for use on USAG-KA are affected by current HPCON B+ measures. Rules governing the operation (including hours and maximum occupancy) of on-post activities, business, or facilities shall be determined by the Garrison Commander. Special categories of services include schools, CDC, and CYS. See Paragraph 1 for guidance.

14. INSTALLATION ACCESS. The US-AG-KA Commander determines installation access changes in accordance with HPCON B+ measures. Currently, all unofficial day guest sponsorship, community exchange sponsorship, 480s, domestic workers program (except those with ETP for home childcare), commute list program (Roi-Namur is excluded from these restrictions due to conditions on 3rd Island) are suspended. For exceptions to this, contact USAG-KA Host Nation Office. See Paragraph 1 for guidance, if required.

15. PUNITIVE ORDER. Paragraphs 3, 8, 9, 11, and 12, of this order are punitive. Persons subject to the UCMJ who violate this order may be punished according to its provisions or face adverse administrative action. Persons not subject to the UCMJ may face administrative sanctions to include suspension or revocation of privileges and removal from the installation, suspension or termination of access to Government facilities and possible criminal prosecution.

16. INDIVIDUAL AND UNIT COM-MANDER RESPONSIBILITY. Individuals subject to this order have the duty to know and understand these prohibitions as well as all applicable provisions of local authority public health orders. Supervisors will ensure their personnel are briefed on the prohibitions and requirements of this order.

17. EFFECTIVE DATE. This order is effective immediately. This order will remain in effect until rescinded by me or superseded by a new order.

Vandenberg Space Force Base, Calif.—An operational test launch of an Air Force Global Strike Command unarmed Minuteman III intercontinental ballistic missile launched from Vandenberg Space Force Base Tuesday, Aug. 16, at 12:49 a.m. PT.

The purpose of the ICBM test launch program is to validate and verify the safety, security, effectiveness, and readiness of the weapon system, according to Air Force Global Strike Command. Col. Bryan Titus, Space Launch Delta 30 vice commander, was the launch decision authority.

"Tonight's success is due to the hard work and dedication of Guardians and Airmen from across Team Vandenberg whose contributions are vital to our nation's security," said Titus. "These test launches demonstrate the readiness of U.S. nuclear forces and provide confidence in the lethality and effectiveness of the nation's nuclear deterrent."

SHIPSHAPE AND SEAWORTHY: USAV MYSTIC TRANSITED TO AUSTRALIA

The U.S. Army Vessel Mystic tugboat recently returned to Kwajalein Atoll after transiting to Cairns, Australia for routine maintenance.

Now back in service on USAG-KA, the 41-year-old floating workhorse sports a sleek coat of haze gray paint and a large Installation Management Command emblem, a special new touch requested by USAG-KA Marine Department Officer Chief Warrant Officer 3 Michael Schafer.

The Army keeps rolling along because the tugboats like the Mystic sustain and support the integral shipping and refueling operations of its remote community.

Capt. Raymond Chamberlain and Frank Zink, ship's engineer, were tasked with making the long voyage to "the land down under" to bring the Mystic in for maintenance. They began their journey on March 12. Upon their safe return in July, the Mystic had transited more than 4,300 sailing miles. They crossed the equator twice, survived foul weather in the Coral Sea and witnessed the beauty of the deep ocean.

One might say Zink knew the Mystic before he ever stepped onboard. He has worked extensively on similar tugboats during his career. He served in the U.S. Navy for 15 years and worked as a surveyor for the American Bureau of Shipping. In Australia, Zink would perform the critical inspections of the ship's systems and interiors. The trip to Australia was the longest ocean voyage he has ever made by boat.

Chamberlain, a 30-year Navy veteran, served on submarines and Arleigh Burkeclass destroyers. He planned each aspect of the voyage and prepared to take the Mystic through all-weather conditions to their destination.

"It's all about attention to detail and the small minutia of what's going on around you," Chamberlain said. "As a captain, you try to always maintain the big picture

and what's going on."

That big picture included provisioning the tugboat from top to bottom. The crew began their journey with 72,000 gallons of fuel and 10,000 gallons of water.

"I make sure of everything," said Chamberlain. "The weather, our food, navigation: All of it. ...If anyone tells you that the open ocean is not a hostile environment, they're wrong. You're in the middle of the desert. It's just full of water you can't drink."

In Port

Days in Australia consisted of daily meetings between the crew and the ship-

yard teams to review the detailed maintenance schedule. Chamberlain and Zink witnessed much of the testing conducted by the shipyard crew from both outside and inside the tugboat.

Zink often had to crawl deep inside the dark voids to conduct his own inspections. He likened the experience to exploring caves.

First, the fuel tanks are pumped dry, and the crew vacuums up residual oils and ventilates the interior before an inspection by an industrial hygienist, Zink said.

"We go from one end to the other looking at any possible thing that could be a

problem," he said.

Then, Frank clambered down into the belly of the boat.

"Frank spent hours down there," said Chamberlain. "It was a very detail-oriented project from beginning to end, where our daily interactions really set the tone with the shipyard. ... We knew what was going on with our ship every day for the last four months."

Of course, even for a trained professional, this sort of inspection is no easy process. Zink shared the humor of working far below decks.

"You crawl through a wall [and] immediately, bang your head because it's dark," Zink said. "You can't see as you go through the tank because all you have is your flashlight."

Sea Trials

Structural tests, an engine refurbishment, replacement of key fixtures and a new paint job were part of the maintenance process before the crew tested the tug in pre-return sea trials: a test drive.

The battery of tests involved "a lot of working with me," said Chamberlain. "After a thorough inspection, the crew performed a dock trial. All systems were ran to be sure they were functioning safely before going out to conduct a detailed sea trial agenda. Everything doesn't work the way you want. You go out there and you find something that worked well in port. So, you identify it [and] we turn the ship around."

Australia

"Here's my advertisement," said Zink. "If you're going to Australia, skip Sydney, skip Brisbane, skip Melbourne, skip Perth, and go to Cairns. It is a big city that you can walk from one end to the other and a half an hour."

Though neither consumed any Vegemite while in port, both men enjoyed the chance to see the sights in Cairns. Zink enjoyed a Sky Rail tour over the rainforests near the town of Kuranda and got to meet a few real koalas.

Chamberlain watched two red kanga-

roos get into a fight at hole nine on a nearby golf course. He also came back from Australia wearing a green, all-weather outback hat made by Akubra. It has since become a treasured favorite.

Going Home

Chamberlain said he is grateful that Frank Zink and his great technical knowledge of the tugboat will be available to the Marine Department.

"We set some pretty high standards and goals on that ship, and Frank brings the continuity that's going to maintain that," Chamberlain said.

His own mission accomplished, days after returning to Kwajalein, Chamberlain headed out on another adventure. He PCS'd home to see his spouse.

It was hard for the captain to bid farewell to the tugboat.

"I'm in love with it," he said, of the tugboat. "My wife would say she is my girlfriend. She knows after 30 years in the Navy that I'm married to my ship."

Would he make the voyage again?

There is no doubt the answer is yes.

"I want to say thank you to my guys, my crew," Chamberlain said. "Being on the ocean is incredible. The opportunity to sail in today's world and do what Frank and I did is an opportunity we could not pass up. It's an incredible adventure. It's nice going to Cairns, but just the trip alone was amazing. We sailed over 4,300 miles!"

Transiting the Coral Sea

During their return voyage, Chamberlain said they experienced 20- to 25-foot waves that came up to splash the bridge windows.

"On the Coral Sea, 10-foot seas turn into 20-foot seas," Chamberlain said. "Five to 10-degree rolls turn into 20- and 25-degree rolls. You just power through it. It's not like you can turn around. ...It's an incredible feeling. Once the seas start dying down, you notice it right away."

What's life onboard a tugboat like?

"The crew still has the same job every day," Chamberlin said. "Whether you're the captain or the engineer, you have to figure out how to get along."

What's it like being in a different hemisphere?

Chamberlain: "You get into the southern hemisphere, and you start realizing, cyclones go one way and hurricanes go the other."

Zink: "We watched the weather reports in around and around Australia. One day, we were waiting for some spare parts. [The shop associate said] they might have gotten snowed in [at another city]. We were just like, 'Wait—what?'"

How does it feel to see land after being out on the open ocean?

"The night before [you land] it's hard to sleep," Chamberlain said. "You're excited because you're pulling into port. It's when you start looking for land and you see the land where it's supposed to be. It brings a smile, but also, in this case, it's bittersweet because you know it's coming to an end. That's true. It was a thorough joy to be able to do it, and it's a great life experience. I learned some things about myself. It was a great experience."

The Blue Water

"The shade of the water is just this sapphire blue. Granted, [on Kwajalein] a thousand yards offshore, you're seeing it. In most places they've never seen that deep water," said Zink.

"If you ever get the chance to go on a boat about 40 miles off the coast, it's nice at night," said Chamberlain. "You will fall in love with the ocean because you'll look up and you'll see the Milky Way. You'll see the stars clearer than you've ever seen them before in your life. You'll go, 'Wow, this is beautiful. I cannot believe I've missed this my whole life.' That's why I keep saying, yeah, because it's so beautiful out there. Then, you can drive around in the daytime where you have a sea state—nothing—or it's glass out here, and you're going, 'This is incredibly beautiful,' and the day changes by the hour."

QUESTIONS ANSWERED: USAG-KA FACEBOOK LIVESTREAM TOWN HALL

The following questions were asked during the Facebook Livestream Town Hall meeting on August 12.

Q: What will USAG-KA do to support the hospital on Ebeye? I'm hearing there is a shortage on fever reducers and fluids like Gatorade.

A: If there is an official request through the RMI government for support, we will try to provide them with services as long as it doesn't impact our community.

Q: Will the post office be affected by the HPCON, and at what point will it be closed. Some people have medication, and supplements that come through the postal system. A: Yes, there's a possibility that the post office will be impacted by the HPCON levels. The Garrison, along with Vectrus, will work closely together to maintain some level of service. I do ask that the community be patient; there is a potential for impact, pending the level of community spread.

Q: Will the Garrison abide by the "Families First Coronavirus Response Act" and how does that apply to contractors?

A: The Families First Coronavirus Response Act expired on December 31, 2020. That law required companies with greater than 50 employees to give their personnel extra sick leave to deal with

COVID. That way an employee would not have to use up their own sick leave, annual leave, paid time off, etc. either to recover from COVID or to care for a family member who is recovering from COVID. Companies were then able to receive tax breaks for having provided the additional paid time off for their employees.

After Dec. 31, 2020, it became voluntary for employers with greater than 50 employees to offer extra time off for COVID and the tax incentives went away. Thus, many employers ceased providing the extra time off. To determine whether a specific contractor is currently offering extra paid time off for COVID voluntarily, employees should contact their HR department. The Garrison will abide by all leave policies currently in place within the U.S. Army. Garrison employees can check with HR or OPM.

Q: How does this affect working out and playing indoor basketball?

A: Current HPCON (A+) guidance is that all patrons must wear masks in indoor common areas when unable to maintain physical distancing.

Q: Is there any scenario in which individuals currently in quarantine will be released early? Could they not be released if they test negative at day five and had negative Hawaii tests?

A: Individuals currently in quarantine are not going to be released early, per

the USAG-KA command sergeant major.

Q: If we are biking or walking around the island by ourself, do we need masks? A: No

Q: Everywhere has free testing centers, including Ebeye and Majuro. Is there a reason we pay \$125 for residents on Kwaj?

A: Antigen testing is the only required COVID testing; PCR testing is not required unless directed by medical staff and is at a cost to the patient. The antigen test is \$25.

Q: Why the change in the delivery system for quarantine? Is there a reason why someone can't pre-stage a home for someone they are sponsoring?

A: That decision was made by the LOG-CAP contractor and posted.


Q: Is the government going to provide masks at the entrance of governmental buildings?

A: No. The PX and Shoppette currently have masks available.

WHAT TO DO IF YOU GET COVID-19 ON KWAJALEIN

Kwajalein Hospital COVID-19 HOTLINE 5-1103

All persons with symptoms must be tested, either at home with a home test or at the Kwajalein Hospital.

All positive results must be called into the COVID-19 Hotline, during working hours.

Employees should also notify their respective human resources departments.

Free COVID-19 test kits are available online at www.COVID 19.gov/tests. On Kwajalein, the community will utilize the the Test and Treat approach as outlined by the Centers for Disease Control and Prevention.

If you have any symptoms (fever or chills; cough, shortness of breath or difficulty breathing; fatigue; muscle or body aches; headaches; new loss of taste or smell; a sore throat; congestion or a runny nose; nausea, vomiting or diarrhea) isolate yourself, correctly wear a mask over your mouth and nose, and get tested.

- Please call the COVID-19 Hotline at 5-1103 before coming to the hospital.
- If you are experiencing a medical emergency, call 911.
- Drink plenty of fluids and manage your symptoms with Acetaminophen (Tylenol), Ibuprofen (Motrin/Advil) and/ or over the counter cough remedies and decongestants.
- Utilize an island buddy or your human resources department to help with groceries, errands, trash removal and other needs.

If you test positive:

You are required to remain at home for five days, and you must retest on day five. This result must also be called in to the COVID-19 Hotline. If others are in the home, correctly wear your mask covering your mouth and nose, isolate as much as

possible and do not share items. Use a separate washroom if possible, and frequently wash your hands.

- If you retest positive: Remain in your home and test again in five days.
- If you retest negative: After five days and a negative test, you may leave your home, but must correctly wear your facemask covering your mouth and nose whenever you are indoors and within six feet of any person. You may return to work or school. You must call the COVID-19 Hotline with the results of your retest, positive or negative.

Close Contact:

If you have been less than six-feet away from a tested positive person for a cumulative total of 15 minutes or more over a 24-hour period

- If you have symptoms, get tested.
- If you have no symptoms:
- Correctly wear a mask and monitor yourself for symptoms.
 You may go to work or school so long as you correctly wear your mask covering your mouth and nose.
- Get tested five full days after the Close Contact whether you have symptoms or not.

If you have symptoms but test negative:

- You may still have COVID-19.
- Notify your human resources representative of your illness, which may be unrelated to COVID-19. Follow your company HR policies as regards sickness.
- **Normally, stay home** until you have gone 24 hours without symptoms and/or fever (without fever medications).
- If symptoms persist, get tested again.

RMI employees should receive their COVID-19 tests through the Leiroj Kitlang Kabua Memorial Health Center on Ebeye.

YOU'VE GOT MAIL. NEED HELP?

You can designate a postal caretaker to retrieve your packages and mail from the post office when you are not able to do so. Island resisdents may opt to assign a caretaker when planning vacation, while self-isolating after exposure to COVID-19 or a postive COVID-19 test, and while recovering from an injury.

MEAL CARD HOLDERS IN ISOLATION

If you are isolating due to a positive COVID test result, do the following to receive meals from Zamperini Dining Facility using your meal card with the help of a designated caretaker:

- 1) Provide proof of your positive COVID test result to International SOS and their corresponding human resources representative with:
- Name
- Meal card number
- BQ or Facility Name/Number
- Room number
- Local telephone number (not cellular, WhatsApp, Teams, etc.)
- 2) HR's, not individuals, must supply the above information to clint.weaver@vectrus.com to ensure the isolated individual's information is added to the list. The listing will be updated at the COB each day and routed to Food Services personnel for the following day. Please understand this will be done once a day, so there will likely be gaps in meal service.
- 3) Caretaker(s) who will be picking up the meal(s) for the isolated individual must have the meal card number for the isolated individual and their own K-badge in order to sign in at the Zamperini Dining Facility.
- 4) It is the responsibility of the caretaker to deliver the meal to the isolated individual.



Surrounded by hospital equipment and medical supplies, this week Taina Kubulala, head of the Marshall Islands' quarantine team on U.S. Army Garrison-Kwajalein Atoll, packed up the last boxes in the lobby of the Kwaj Lodge. The Marshall Islands' repatriation program had come to an end, and it was time for her next mission: Majuro.

Kubulala arrived on US-AG-KA in October of 2020. Since that time, she has quarantined with each Marshallese repatriation group to arrive on USAG-KA until last month, when the RMI national government announced its planned reduction in quarantine and intention to open its borders on October 1.

Leaving USAG-KA is not easy.

"I've come to see this place as my home," Kubulala said, looking around the Lodge.

Originally from Fiji, Kubulala said she had felt the calling to serve in the medical field as a teenager. Since that time, she has traveled throughout the Pacific working to heal people in the Fijian far outer islands, and most recently, in the RMI. The work has taken her to faraway locales and distant villages to assist in everything from dental work and child immunizations to helping mothers give birth.

"I have walked waist-deep through the swamp, carrying my supplies, to help people," Kubulala said, of her past work.

On Kwajalein, Kubulala coordinated the efforts of the team of nurses and technicians attending to Marshallese guests during their quarantine weeks, performing testing, cleaning and any other tasks required. She was a friendly, familiar face behind a mask on the flightline to welcome returned citizens back home with a temperature check and became a member of the Kwajalein community.

Between assignments, Kubulala and her team members enjoyed visiting Kwajalein's beaches, cooking curries and attending island social events, including Oktoberfest and karaoke nights. Before she left, Kubulala also attended a USAG-KA women's league soccer game between Spartans I Women and Go Green Go.

"I used to play soccer!" she said, and described how years before, given the chance to play on one of two civic leagues, she had opted to start a new team in an area which had no team, just to give those people a chance to play and have fun.

Kubulala said she has enjoyed working with the garrison team. She fondly recalled discussions with USAG-KA Command Sgt. Maj. Ismael Ortega and former Col. Jeremy Bartel, who joked that he had the was going to recruit her into the Army.

Having seen the RMI quarantine program from start to finish and having helped hundreds of passengers safely quarantine before going home, Kubulala said she feels called to continue her work in the RMI. She will next go to Majuro to support medical services as COVID cases continue to mount.

"I am really grateful that I could be here to help and to provide continuity in the quarantine mission," she said.





THE "VOIPOCALYPSE" OF 2019 IS TODAY'S NON-PROBLEM

Searching for perspective this week as life on Kwaj becomes more unusual, I turned to The Kwajalein Hourglass archives.

Any small wrinkle reported before COVID-19 was a known problem struck me as humorous.

I mean, at least we're not still debating about a transition to VoIP.

On May 11, 2019, the KHG team lobbed a public service announcement into the community from the garrison. The topic: The plan to transition the entire island to a VoIP phone system.

Voice over Internet Protocol has since been introduced on the garrison and is now a non-problem. Several folks on island now utilize VoIP exclusively for communicating at work or calling home, and they like it fine. It's still nothing like the sweeping service updates we parsed at our past town hall meetings.

The question of VoIP had loomed over the island since 2018, the year of the LOGCAP IV transition, concurrent with yet another transition for all island internet networks.

For those who sustain our vintage island telecommunications infrastructure, going "full VoIP" would surely have been

a nightmare.

It wouldn't have been fun for the rest of us, either. To reach 911, we would instead have had to dial 1-805-355-5911.

It was a tough sell, but someone came up with dubious VoIP "benefits" to share. The KHG published them.

VoIP included zero government monitoring of our phone conversations, a personal phone number that belonged to us and signing our personally identifiable information over to any number of for-profit companies to ensure loved ones could be reached outside of work via long-distance calls.

"VoIP technology uses your internet connection to make phone calls instead of traditional landlines or cellular towers. This method is a much cheaper option than the traditional methods and is popular worldwide."

The kicker: "The only residential long-distance calling option will be 'Voice over Internet Protocol' phone call systems," read the 2019 PSA.

After weighing the evidence, the 2019 community decided VoIP was The Worst Thing That Could Possibly Happen on Kwaj. It was right up there with whomever didn't wave to you while biking past, shortages of avocados and dairy products

and that soft drink dispenser in the Food Court. You know, the one that didn't work for three years.

I am still not an experienced VoIP user, and it's due to a friend of mine. I would receive an occasional raspy VoIP phone call as he informed me that he alone had been clever enough to spot the nugget of joy on page eight that would become next week's correction.

At least I think that's what he said. The reception was terrible.

No one wants Darth Vader correcting their grammar.

In the spirit of being prepared, I did go out and purchase a VoIP system. It lies somewhere in a box marked for donation to the Bargain Bazaar. I'm sure of this, but only because it's the last place I haven't looked. I'm content to leave it there.

All these years later, the VoIP PSA suggests an inconceivable alternate reality—much like life on the atoll this week after the worldwide pandemic began to spread through our precious communities.

Thank goodness we still have those landlines.

I am grateful we can pick up plain old telephones to call 911 or the COVID Hotline at 5-1103 to help track community spread and to check in on our friends.

Even so, I would trade the pandemic for that broken down old soft drink dispenser any day.

BOTTLE IDENTIFICATION TIPS

If you spot a vintage Coca-Cola bottle on Kwajalein, you may be able to tell how old it is by locating a few manufacturer's marks stamped into the glass. But what should you do if you spot a unique bottle?

Kwajalein Archaeology has a few tips to help you when you next find a bottle on the shore.

"With many bottles you can find the date and manufacturer," said Susan Underbrink, Kwajalein archaeologist.

Underbrink has a running catalog of bottles found in and around the atoll and knows a thing or two about how to determine the age of the glass from its manufacturer's stamps and markings.

Many are unique, and some can be hard to find in the fine patina of the bottle's surface.

Look closely and you can see the marks on the underside of a bottle, as in photo one.

"The odd symbol stands for American National Can Company, and they used this symbol from 1987-2000, and this bottle base is from 1995," said Underbrink. "So, this is a modern bottle—meaning, not historic."

In photo two, the smooth, clear base of the bottle shows the date 56, for the year 1956, and the maker's mark for the Imperial Glass Company.

"The purple box on the Coca-Cola bottle in photos three and four denotes where to locate the information," Underbrink said. "The pink box is usually the plant number. The purple box is the manufacturer, in this case, Owens Illinois, and the green box is the date." The bottle in image four is from 1945.

If you happen to find Coca-Cola bottles that are not from Owens, Illinois, you are encouraged to contact the Kwajalein Archaeology Office. Underbrink can help you identify them.


"Remember you can enjoy them while you are here, but they are not to leave the island," Underbrink said.



TIPS TO CONSERVE WATER

Don't let our precious resource drip away. To make water conservation a habit in your home, follow these steps to keep the installation's water tanks at safe levels:

Only water your plants and lawn with reclaimed water.

Turn off the faucets at the island's SCUBA dip tanks.

Do not fill dip tanks to the brim unless there are enough people washing gear to justify using a large amount of water.

Report all water leaks to the Department of Public Works Service Desk at 5-3550.

Take a shower instead of a bath. A five-minute shower uses about 25 gallons of water, while a full-size bath consumes double that amount.

Take shorter showers.

Chill drinking water in your refrigerator instead of running the faucet until the water is cold.

Fill a container with water and use a vegetable brush to wash veggies.

Your washing machine uses up to 34 gallons of water for each load of laundry and your automatic dishwasher uses up to 11 gallons? To save water, wait to run these appliances with a full load of laundry.

E-WARENESS: PETROLEUM STORAGE TANK ANNUAL INSPECTION

Each department must inspect tanks weekly via trained custodian:

Examine for and remove water.

Examine secondary containment areas to ensure they are impervious to water and draining properly.

Inspect for paint failure and corrosion.

THINK BEFORE YOU BIKE

Ride a bike that fits you—if it's too big, it's harder to control.

Ride a bike that works—it really doesn't matter how well you ride if the brakes don't work.

Wear equipment to protect you and make you more visible to others, like a bike helmet, bright clothing during the day, reflective gear and a white front light and red rear light and reflectors on your bike at night or when visibility is poor.

Ride one per seat, with both hands on the handlebars, unless signaling a turn.

Carry all items in a backpack or strapped to the back of the bike.

Tuck and tie your shoelaces and pants legs so they don't get caught in your bike chain.

Plan your route—if driving as a vehicle on the road,

choose routes with less traffic and slower speeds. Your safest route may be away from traffic altogether, in a bike lane or on a bike path.




GLASS BEACH OFF-LIMITS TO UNAUTHORIZED PERSONNEL








UXO REMINDER

PUBLIC SOFFTY ANNOUNCEMEN

Remember the three Rs of UXO: Recognize an item as possible Unexploded Ordnance. Retreat from the area of the UXO. Report suspected UXO immediately by notifying EOD (5-1433) or CPS (5-4445).

Provide the following information: Location (building #, GPS, landmarks, etc); Size (compared to common items - football, scuba cylinder, etc). Treat UXO like you would treat dangerous sea creatures. Look but do not touch. For a detailed refresher, please attend the Island Orientation Briefing on the fourth Wednesday of every month.

Using a password manager, use upper and lowercase letters, numbers and special characters, as well as, two-factor authentication (two methods of verification). Watch for suspicious activity that asks you to do something right away, offers something that sounds too good to be true, or needs your personal information. Think before you click, and when in doubt, do NOT click. Do not provide personal information. Use encrypted (secure) Internet communications. Protect your home and/or business using a secure Internet connection and Wi-Fi network. Use a strong authentication such as a personal identification number (PIN) or password that only you would know. Check your account statements and credit reports regularly. Only share personal information on secure sites (look for "https://"). Do not use sites with invalid certificates. Use a Virtual Private Network (VPN) that creates a more secure connection. Use antivirus solutions and firewalls to block threats. Regularly back up your files in an encrypted file or on an encrypted file storage device. 



WEATHER DISCUSSION

Conditions dry out for Kwajalein Atoll after moderately rainy week. Lingering showers from Friday night will persist into Saturday morning, but mostly dry weather is expected for rest of the weekend.

The Intertropical Convergence Zone is expected to vacate the area and with winds so light, minimal forcing exists for shower development this weekend.

Winds will be in the single digits and highly variable, matching doldrum-esque weather.

By late Monday/early Tuesday a wind influx will occur, producing showers for the morning, but models currently indicate a mostly dry work week after that period settles.

Weak waves will move through atoll throughout next week, but shower activity looks to be low.

SATURDAY

Mostly cloudy with scattered showers early, decreasing to partly cloudy with isolated showers for the afternoon and evening. Winds will be light and variable at 3-8 knots.

SUNDAY AND MONDAY

Mostly sunny with stray showers. Winds will be NNE-ENE Sunday, shifting ENE-ESE on Monday at 3-8 knots.

TUESDAY

Mostly cloudy early with scattered showers, decreasing to isolated showers by noon. Winds will be ESE-SSE at 7-12 knots.

NEXT WEEK'S OUTLOOK
