

INTENSE (BUT FRIENDLY!) COMPETITION AT THE PAUPERS' MARATHON

HOURGLASS REPORT

"The ladies beat the men," said Bob Sholar, president of the Kwajalein Runners' Club, with a look that was difficult to read. Bob reported his winner's information for the traditional Kwajalein Paupers' Marathon that took place on Monday, December 9, 2024.

So named, because it's the local version of the prestigious Honolulu Marathon provided for residents that couldn't afford the rather extravagant expences of the Hawai'ian event, the Paupers' Marathon date and start time are synched up to that of the bigger event's timezone. This increases the Kwajalein event difficulty since our 3 AM start time is objectively more challenging than their 5 AM start

"Mandy Melody has the running bug," continued Bob. "and she kept going for 85 miles! That's more than three marathons! A Kwajalein first by far."

Four teams completed the marathon (teams could be composed of anywhere from 2-to-10 runners). A highlight was seeing the school teacher team compete against the students. The Giant Stride Award went to Jackson Ladd anchoring the students' team which finished second behind the first place teacher team.

Kwajalein Reclaimed Water Standard Violation

The Reclaimed Water System Document of Environmental Protection (DEP) requires public notification when reclaimed water standards are not met. For approximately 8 hours on November 13, 2024, the minimum residual chlorine concentration level at the Point of Entry to the Kwajalein reclaimed (or non-potable) water distribution system dropped below the 1 mg/L standard. Chlorine is added as a disinfectant at the Point of Entry into the Reclaimed Water System. Additionally, during 17-19 November 2024, the 7-day rolling turbidity average at the point of entry into the reclaimed water system measured above the 2.0 Nephelometric Turbidity Units (NTUs) standard. Turbidity is the cloudiness or haziness of a liquid caused by particles that are generally invisible to the naked eye. No health-based restrictions on the normal use (irrigation, vehicle washing, etc) of reclaimed (or non-potable) water are necessary. There is no threat to public health or the environment resulting from this turbidity exceedance. If you have any questions, please contact the V2X Environmental Department at 480-0722.



A strong, but not unpleasant smell of stoneware clay greets you when you walk into the Kwajalein Hobby Shop. Surprising, since it shares the 815 facility with the equally fragrant Wood Shop, but the tell-tale scents of the latter do not overpower the clay smell at all.

Our visit was owed to Michelle Soto's Pottery Throwing workshop, which took place on Friday, December 6, 2024. "The hobby shop is painted with vibrant colors," said Ms. Melissa Dethlefsen, LOG-CAP V V2X IMD media personnel. "This makes it an inviting space with creative vibes."

The Hobby Shop offers:

<u>Ceramics Molds</u> - staff will instruct you how to properly pour and take care of molds.

<u>Pottery</u> - Staff provides individualized instruction and hand-building, as well

as monthly classes and events.

<u>Hobby Shop Library</u> - features specialty books on ceramics, pottery, and woodworking.

'Safety is very important at the Hobby Shop. Always wear closed toe shoes and wear safety protection when needed," said Anne Hisle, MWR Technician. "I'd have to say that I really like that it's a good place for people to come and just have fun and be creative. Some people come in and just want do 'x' but get inspired by others and learn a whole new skill that they never thought they would do. Some people bring their kids in and end up doing something themselves. It's very satisfying to see folks who have never made anything come in, make something from scratch and then be able to take a functional or decorative handmade piece home that they can be proud of."

POSTMASTER UNIVERSITY | SHIPPING HAZARDOUS MATERIALS (HAZMAT) & DANGEROUS GOODS (DG) INTERNATIONALLY

HOURGLASS REPORT

Postmaster here! Great question! When you ship something from the United States to another country, you must follow both USPS international shipping regulations and the regulations of the destination country. Some items are prohibited (completely forbidden). Some are restricted (allowed under certain conditions). Hazardous materials (HAZMAT), also known as Dangerous Goods (DG), may be prohibited or restricted.

What Is Considered Dangerous Goods Shipping?

Hazardous materials (also known as dangerous goods) are substances that could injure people or cause damage if not handled properly, like chemicals or flammable items. HAZMAT also includes lithium batteries (like the ones in cell phones and electronics); they contain a lot of energy and can be a fire risk.

Some HAZMAT is prohibited—you can't send it through USPS and must use another carrier.

Some HAZMAT can only be sent in sealift and ground transportation—it can't go on airplanes. For APO/FPO there's a chance it will take at least 30 – 45 days transit time.

Dangerous goods are more common than you may think.

Most rejected mail is due to the reuse of packaging and boxes. Reused packaging and boxes are only acceptable when all markings and labels are removed or completely blotted out. Regardless of what is inside your package, displayed markings or labels for DG may result in delivery delays or a package return.

There are even some items that can't be shipped from Kwajalein. Keep reading below for some specific examples.

<u>Lithium Batteries</u> - For domestic mailings only, small consumer-type primary lithium cells or batteries (lithium metal or lithium alloy) like those used to power cameras

and flashlights are mailable domestically under certain conditions.

Lithium Batteries in Electronic Devices - If you're mailing used, damaged, or defective electronic devices containing or packaged with lithium batteries, you must send them via ground transportation; they are prohibited in air transportation. These devices must be marked on the outer packaging with the text, "Restricted Electronic Device" and "Surface Transportation Only."

Believe it or not, hand sanitizers fall in a protected category. Most hand sanitizers, including wipes, contain alcohol and are flammable

in nature and are therefore handled and shipped as hazardous matter (HAZMAT) in the U.S. Mail. As flammable materials, these products are limited to surface transportation-only in domestic mail. It is prohibited to send these materials by International Mail including APO/FPO/DPO (military) destinations.

Aerosols - Examples of mailable gases and aerosols include propane, butane, and fire extinguishers. Make sure you read about the specific rules and restrictions for sending mailable gases.

Medicine - When sending medicine or drugs through the mail, mailers and shippers must know the characteristics of the items they are sending and treat them correctly. Medicines are controlled substances and are subject to strict regulations. Prescription medications may only be mailed by Drug **Enforcement Administration** (DEA) registered distributors. Similar regulations apply to some over-the-counter medications.

If you are unsure whether the product that you are shipping is flammable, please check with the trusted Postal staff for guidance, additionally, there is printed information in the Post Office to help guide you through the process.


EARN YOUR TEAM KWAJ TAB

- 1. Attend Col. Morgan's TEAM KWAJ brief (either Teammate or Community version), read and adhere to the TEAM KWAJ Teammate Pact, presented at initial town halls, and periodically thereafter.
- 2. Attend the Island Newcomer's Briefing.
- 3. Attend at least one group greeting at air terminal for personnel arriving on island. Make them feel welcome and show them we are happy they are on Kwaj with us.
- 4. Attend at least two garrison after-hours team-building or social events (TEAM KWAJ Happy Hour, Commander's Call, Hail/Farewell).
- 5. Attend at least two TEAM KWAJ PT/Wellness sessions. Become a regular attender!
- Visit Marshallese Cultural Center in last 3 months prior to tab award.
- 7. Visit Ebeye, Third island or Majuro in last 3 months prior to tab, use a Marshallese phrase or two and visit a store/restaurant.
- 8. Tell three co-workers how to earn the TEAM KWAJ tab.

- 9. Swim, snorkel, boat or paddle on the lagoon at least once with a teammate.
- 10. Complete the TEAM KWAJ Circle-island 6-mile ruck march/walk/bike and read all historic battlefield markers. This is an organized USAG-KA hosted event several times per year.
- 11. Mission Partner wild card event—discuss with your supervisor any additional organizational requirement. Could be knowledge-based, achievement-based, or physical challenge.
- 12. Final event, "Board of Review" -- meet with Col. Morgan face-to-face individually or in a small group with all requirements fulfilled. Schedule with garrison front office. Discussion items may include but are not limited to; TEAM KWAJ pact - "Healthy Community of Excellence," Kwaj history, Marshallese culture, military/strategic missions and their significance, and future operational potential.

MARSHALLE CULTURE THE INTRICATE STRUCTURE OF THE JOWI

HOURGLASS REPORT

Wealth among the Republic of the Marshall Islands peoples is measured in land ownership. The right to land is directly connected to jowi, or a citizen's allegiance to a particular clan, which is a genetic, or blood tie. The exact number of jowi across the Marshall Islands is unknown, since the records that carefully recorded exactly who was related to whomever else did not make it pass the Great War. Today, the vast majority of the Marshallese are Christians, and the old ways of tracking relations through the jowi tree branches were strictly tied to the traditions of the old religion, now lost. The resurrected jowi tie records have the memories of what the elders considered themselves related to which jowi are what hold them together. Official rules were put in place to govern and distinguish one jowi from another in order to ensure a straight an dplain inheritance flow throughout the succeeding generations. This also serves to enable the iroijs and other higher ranks to guard the integrity of regality and royal blood,

and prevent accidental incestuous relations, that could potentially damage the genetic line[s].

Every citizen belongs to a jowi, every jowi swears its fealty to its Iroij, or "chief." The Iroij are supervised by their Alap or "clan heads"—also called Iroijlablab—and these in turn are supported by the Drijerbal, or "workers," which includes the patrilineal offspring. This is a necessary distinction, since inheritance rights and other jowi benefits are passed down through the matrilineal paternal line.

Although non-Marshallese are not allowed to purchase land, land purchases by the Marshallese themselves is itself not likely to happen. The Iroijlablab often grants rights to land, but the actual ownership remains with the Iroij class, who maintain ultimate decisions as far as "land tenure, resource use and distribution, and dispute settlement." According to tradition, there were originally 8-original jowis that grew to the approximately 40-50(?) known today.

WEEKLY TROPICAL WEATHER THREAT OUTLOOK

Discussion:

So far in December up through the 18th, we have received 4.57 inches of rain, which is 0.15" below normal for the month. For the year, the weather station has received 88.06 inches of precipitation, which is 2.25 inches below normal. December is our transition month from the Wet Season (Ellap Wot) to the windy drier season (Ellap Kutu). We experienced no thunderstorm days during the last seven days, as the vertical dynamics of the atmospheric column remained mostly negative over the last week for lightning development. This is defined as an "in situ" lightning strike within five miles of the weather station. Lighting was observed about 80 miles south of Kwajalein Atoll, closer to the reestablishing ITCZ yesterday. The Intertropical Convergence Zone (ITCZ) has reestablished itself, and is currently stretch east-west across the southern RMI. The trend of the ITCZ remaining mostly across southern RMI, will be with us for most of the remainer of December, helping to induce a steeper pressure gradient for winds to sustain in a range of 13-18 knots outside of showers with a few clear-air gusts to around 20. Shower coverage for the central RMI has now increased. We will see greater shower activity today and

tomorrow via minor troughing in the lower atmosphere, with a lull in activity for the weekend, and then expect shower coverage to pick back up again on Christmas Eve, and continue through the holiday. The Madden/Julian Oscillation (MJO) has now entered a moderately positive phase over the Marshall Islands. The positive phase of this global tropical circulation basically has the effect of helping to augment shower coverage for our part of the Pacific. This factor will result in at boost to the Intertropical Convergence Zone (ITCZ), when it is in the vicinity of the central RMI. The negative phase has the opposite effect. The El Nino Southern Oscillation (ENSO) is in mild La Nina conditions with the central Pacific (area to the east of the RMI) actually in a cool anomaly greater than that of the eastern Pacific, where currently conditions are actually only vaguely cooler than normal. This cool anomaly in the central Pacific tends to work again tropical cyclone development to the east of the RMI, where it could pose a threat to our region. We are also moving out of the tropical cyclone season as a whole for the western Pacific with the northern winter now climatologically in place.

Tropical Cyclones:

No significant tropical cyclone activity expected to affect anywhere in Micronesia, the Mariana Islands, Wake Island or Hawai'i. We are now in climatological winter for the northwest Pacific, which generally bring a considerable decline in tropical cyclone activity. There is Invest 97W located over the central Federated States of Micronesia, and is expected to move to the west farther from the RMI.

<u>Damaging West Winds /</u> <u>Westerly Swell</u>:

None expected. Micronesia is northeast trade wind dominant.

<u>Swell / Tide Inundation</u> <u>for Kwajalein Atoll and</u> Wake Island:


The waning half-moon is on the 22th, which means that all high tides will be neap tides levels below 4.0 feet, before increasing again moving toward the spring tide phase with the new-moon on the 30th. Trade-winds out of the northeast will remain at Windy Season levels for the most part at 12 to 17 knots with the occasional clear-air gust into the low-20s and gustier winds, as showers arrive over our area just off to the immediate east. Look for a bounce in the winds to the upper teens on Saturday afternoon and again on Monday afternoon, as we see a steepening of the pressure gradient. With the winds having spent most of last week in the middle teens, and winds expected to sustain for the most part at

that level, wave heights will be between 7-9 feet on the open ocean. As we move into the neap tide level, no issues with splash over are expected. No major swells expected from mid-latitude storms in the northern Pacific for Kwajalein. It appears that High Surf Advisory conditions will be met for a short period of time at Wake Island on the 26th as a northeastern swell, which is the more vulnerable direction for the island.

Purpose: This weekly briefing is delivered Thursday mornings to island leadership. The intention of this briefing is to provide situational awareness of weather events that may interrupt operations and transportation around Kwajalein, to/ from Hawaii and Guam, and in the Wake vicinity. The main threat assessed in this brief is existing and potential development of tropical cyclone activity. This brief also provides an outlook of abnormal winds, sea state, and precipitation guidance for next 7 days around the Kwajalein Atoll. The distribution list will also receive updates on any developing tropical cyclone activity in the Kwajalein region that occur between the weekly outlook product.

WEATHER DIS-CUSSION

Drier conditions will move over Kwajalein Atoll this afternoon, with only a few stray showers expected. The Intertropical Convergence Zone (ITCZ), a band of clouds and storms, is still over the southern Marshall Islands. However, the section that affected Kwajalein will move west, and its impact will lessen. Winds will be breezy, generally in the upper teens, with gusts reaching into the low 20s, mostly coming from the east-northeast. Occasionally, passing showers could bring stronger winds from higher up in the atmosphere, which could shift to the

east-southeast, reaching speeds of about 30 knots. The weather will remain dry and breezy tomorrow through the weekend, as strong high pressure keeps things stable and winds come from the northeast. Early next week, the ITCZ may return, bringing some rain back to the atoll.
